Subject: McCaffrey-Raines Meeting on Performance Measures

Today, Raines met with McCaffrey on ONDCP's aggressive, draft government-wide performance measures. As you know, ONDCP has proposed a 50% reduction in demand and a 50% reduction in supply by 2007. In brief, Raines agreed to allow ONDCP to publish aggressive performance measures as long as several conditions were met:

-- Other agencies that have objected (e.g., HHS, DOJ, Treasury) must be brought on board.

-- The performance measures should not be perceived as measures for the Federal Government to achieve. Rather, they should represent societal goals, in partnership with the private sector, States/localities, foreign governments, and behavioral changes in society. Also, the performance measures should take account of the desirability of reallocating Federal drug control funds from programs of lesser effectiveness to greater effectiveness.

-- As such, the performance measures are disconnected from the Federal budget and should not be used to drive outyear budget funding levels.

LRD (Jukes and Jones) will be drafting suggested changes to the ONDCP draft text currently in circulation to reflect this agreement.

Two quick talking points we could give to those who talk to the press in advance of the MLK speech/EEOC announcement:

First of all, don't play up or overhype the speech; it's not the VP's big, definitive speech on race. He's not even the keynoter at Ebenezer Baptist Church on Monday, and he will focus on the life and lessons of Dr. King. He's spoken on race many times before, and he will do so many times again.

That being said, in addition to making the EEOC announcement, the VP will push back at our conservative critics on race (in particular, those who think we should ignore race and abandon all race-based remedies). He will make the point that race does indeed still matter in America; that the roots of discrimination run very deep; and that we still need concerted action -- by government, and by all Americans working together -- to fight racial and ethnic discrimination and to build One America (which is why we are taking new steps to more vigorously enforce our civil rights laws).

Immigration -- INS Reorganization. We have completed our review of proposals to restructure the nation's immigration system, including the final recommendations of the Commission on Immigration Reform (CIR). In its final report, the CIR called for the separation of the enforcement and service functions that INS now performs, through reallocation of major functions to other agencies. After consultation with representatives from the Department of Justice, the INS, the Department of State, the Department of Labor, members of the CIR, and immigrant advocacy groups, we have concluded that though the functional separation of service from enforcement is an effective way to improve the administration of our immigration laws and policies, this separation is best achieved through reform within the INS rather than through a dismantling of the agency. This functional separation within INS will strengthen accountability and lines of authority, while making the agency more efficient and effective in carrying out its interrelated responsibilities. DOJ has entered into a contract with a private consulting firm to assist them in designing a reform plan that meets our goals. Over the next few weeks, we will be meeting with INS, DOJ and the contractor to assist in guiding this development.
