Thank you for your note regarding the proposed rule for national organic standards, and for forwarding me your submission to the U.S. Department of Agriculture (USDA). I agree with you that the issues are of great importance to the future of organic foods, and hope you agree with the recent steps we have taken in this area.

As you may know, since you sent me your letter, USDA has announced that it would make fundamental changes to its proposed national organic standards. Specifically, USDA will issue a revised proposal for public comment that will not allow foods produced with biotechnology, irradiation, and biosolids to bear the organic label. Before publishing the revised proposal, USDA will evaluate the comments submitted in response to the December 1997 proposal. This record will guide the drafting of the revised proposal, which USDA will issue for public comment later this year.

Thank you again for submitting your comments to USDA and forwarding them to me. I believe we will substantially improve the revised proposal as a result of comments like yours and many others.

I just got a heads up from the Education Department and Kennedy's staff that the Coverdell-Craig-Abraham Drug-Free Neighborhoods Act amendment to the Tobacco bill may well contain a provision, offered last year by Senate Republicans, that allows federal funds to be used to give vouchers to kids who are victims of school violence, including drug-related crimes.

The overview/summary of the bill reads: DRUG-FREE SCHOOLS: makes it an allowable use of federal funds to provide school choice or compensation for k-12 students who are the victims of school violence, including drug-related crimes...."

In the education world, a tobacco bill that doesn't have class size reduction but does provide for vouchers would be seen as a complete disaster. I don't know where things stand in the negotiations over this amendment, but it would be great if we could indicate that this particular provision would be a deal breaker. Otherwise, the R's may be using this to set the Dems up to take responsibility for bringing down the tobacco bill.

As you know, POTUS requested to VPOTUS to look into reinventing bilingual ed:

Morely held a meeting on this a week ago (Karen, Maria and I met with Morley and Jennifer Muller on his staff). My approach at that meeting was to make sure Morley understood the context in which we are already operating and that anything he did fit within our larger effort.

I also understood that the POTUS request to VPOTUS indicated that he may not be entirely satisfied that the principles he signed off on--and legislation translating them into action-- constitutes the complete set of actions needed to strengthen bilingual ed.

None of us has a clear sense of what a "reinvention effort" for bilingual ed would look like, particularly since the principles we have developed--focus on result (3-year goal), increased accountability, greater local flexibility, and an emphasis on quality (including better trained teachers) are already a big step toward reinventing the program. Nonetheless, we thought we owed it to both POTUS and VPOTUS to think about it some more before throwing in the towel. We are meeting again tomorrow afternoon to see if we can figure anything out.

While I don't believe there is anything uniquely "reinvention" about this, NPR (with proper guidance and continued close connection to DPC) could potentially develop several issues that would further our efforts:

1. Further specification of goals and indicators. We have not been very clear about what we mean by "learning English within 3 years." The experts basically say that you can get most kids to be fluent in speaking English in less than 3 years, that it will take longer than that to get many kids to grade level in reading comprehension in English, and that reading in English really well enough to learn science and other academic subjects is a task that takes forever, even with kids whose native language is English. Further, the bilingual experts in particular would claim that the only goal worth pursuing is the most demanding one; anything less sells the kids short. By taking this position they also reinforce the notion that they are in no rush for kids to learn English in any form--thereby digging the hole they are in even deeper.

I think it could be helpful having someplace that is less tied to the

experts than the Education Department make some effort to sort this out, and propose a set of goals and indicators that are sound politically and programatically.

2. Highlighting what works. NPR could look for examples of places that are meeting the goals, as further specified, which we could highlight to help build support for our legislation.

3. Broadening the view of bilingual education. While we have viewed bilingual ed as a program to help LEP learn English, we periodically encounter an argument that we ought to be encouraging more kids in this country to become proficient in two languages, or order to help them and us be competitive in a global economy. This is an argument that all of the Dem. gubernatorial candidates in CA made during the debate over Unz; it also generally fits the President's theme of One America--at least insofar as it recognizes that immigrants and others whose first language is not English bring some assessts. While I've always been concerned that coming out in favor of having many kids speak two languages is a bit too transparant as a last ditch defense of bilingual ed, I also think there is real merit in encouraging and helping more kids in this country to learn another language. It would be good to have somebody thinking this through as part of our overall approach.

NPR is not uniquely situated to address these, but might be able to help. Any guidance on these issues, or on whether to carve out a role for NPR?

TALKING POINTS ON AIDS

June 4, 1998

Q: Is it true that President Clinton has lied to and betrayed people with AIDS?

A: The President continues to make the fight against HIV/AIDS a top priority. Since he took office:

funding for care and treatment for people living with HIV/AIDS has more than tripled and funding for research has increased by 50%

drug assistance programs that provide promising new therapies to people with HIV/AIDS have increased by more than 450%

a new vaccine research center is being built at the National Institutes of Health to focus on the President's goal of finding an AIDS vaccine within 10 years

drug approval at the Food and Drug Administration has been accelerated to record times

Q: Is it true that the The President's own Advisory Council on HIV/AIDS is prepared to resign as a result of his decision not to fund needle exchange programs?

A: While some members of the Council have expressed frustration from time to time, we are not aware of any plans for resignations. On the contrary, the Council members realize that their participation

gives them a unique opportunity to develop policies that best meet the needs of people living with AIDS.

Q: What is your reaction to the criticisms of the Administration's position on needle exchange?

A: The Administration is committed to reducing the transmission of HIV and reducing drug use. We believe that the recent decision was the best way to advance these two goals. The Secretary of Health and Human Services made clear that appropriate needle exchange programs can cut HIV transmission without increasing illegal drug use. At the same time, the Administration tried to prevent the politicization of needle exchange by keeping decision making at the local level. We understand that this decision raises strong feelings on both sides, but we think that HHS's release of the scientific findings relating to needle exchange was critically important.

PRESIDENT CLINTON: PREPARING AMERICANS FOR THE FUTURE

June 4, 1998

"As President Franklin Roosevelt said, a secure retirement rests on a three-legged stool: Social Security, private pensions, and private savings. All of us --government, business, and individual Americans --must do our part to make sure that these three legs serve our people well into the next millennium."

Today, the President is joined by Vice President Gore, and the bipartisan leadership of Congress, in attending the SAVER Summit, which will address the need for greater savings and pension opportunities for the American people. The President will affirm that existing laws permit employers to automatically enroll new employees in 401(k) pension plans, unless they opt out.

THE NEED FOR ACTION. American workers generally need three elements to ensure financial security in retirement: (1) Social Security; (2) an employer-provided pension plan; and (3) personal retirement savings. Currently, Social Security is the sole source of income for 18 percent of all elderly Americans, and the primary source for two-thirds of all senior citizens. For over five years, the President has worked with Congress to expand pension coverage, make pensions more secure, and simplify pension plan administration. Despite these achievements, the personal savings rate among Americans remains too low, and many workers do not have pension coverage through their employers. Research shows that:

- **More than 50 million employees** -- half of all American workers, are not covered by a pension plan;
- **Only 15 percent of private sector workers under age 25** are covered by a pension plan;
- **Only 21 percent of private sector workers earning under \$15,000** a year are covered by a pension plan;
- **Only 24 percent of full-time workers in firms with fewer than 100 employees** are covered by a pension plan.

A NEW EFFORT TO INCREASE PENSION COVERAGE. At today's SAVER Summit, the President will announce that current law permits employers to structure 401(k) plans so that new employees are automatically enrolled unless they opt out. Under standard practice, employees are not enrolled in 401(k) plans unless they opt in. Automatic election into 401(k) plans would:

- **Automatically enroll new employees** in company sponsored 401(k) plans, while giving the employee notice that they can choose to opt out of the program if they wish;
- **Encourage participation in 401(k) plans** for some workers by eliminating the opt in requirement;
- **Potentially raise 401(k) investment rates.** Available research shows that companies with an automatic enrollment policy have participation rates of 90 percent, while the overall 401(k) enrollment rates is 67 percent.

BUILDING ON A RECORD OF INITIATIVES TO INCREASE INVESTMENT. Today's announcement builds on other initiatives that the President has called for in his budget plan, including:

- A tax credit for small businesses that adopt pension plans;
- A benefit plan for small firms that is simplified and better defined;
- Encouraging those employers who do not offer pension plans to allow employees to contribute to Individual Retirement Accounts (IRA's) through payroll deductions;
- Reducing the vesting period for employer 401(k) plans from five years to three.
