not sure what POTUS wants to do with this, but here are two items for your information:

1. NPR held up the letter from the cabinet agencies to state's regarding our new rules until we could gain agreement that state's submitting unified plans would not have to send one to every agency they wanted money from. OMB and NPR convinced DoL that they should take lead in becoming single point of contact for responses. Apparently there was lots of turf issues between them and DoEd. on how to do this. We are working to present a seamless interface, but be careful of what he says about it.
2. Inter-Governmental Affairs and NPR met with the National Governor's Association on a series of federal/state partnership issues and WIA was of great interest to NGA. We offered to work with them in finding 6-10 states who would be targeted for submitting truly unified state plans NEXT APRIL. This will require a taskforce between NPR and NGA to work with agencies involved to get focus on helping people improve their incomes vs. deciding which program is meant for what problem.

Thanks for forwarding me this info, Kris. Let me know if there is anything we should do in anticipation of an event.

Also, as some of you know, the Black and Hispanic Caucuses have raised major concerns with the President's ideas on social promotion. I understand there's a meeting over there on it today and people from ED will be there to express our, and particularly, my concerns. Remember that we did not adequately address similar concerns raised by these groups on the national test and we not only didn't get their support, but their lack of support was unhelpful in trying to get it through. You'll all remember, I believe, that

the majority used the fact the POTUS' own base wasn't supporting the test to help defeat it. Already, there have been editorials and articles in newspapers around the country on how ending social promotion will disparately and disproportionately affect minority children. Whatever the merits are or are not of those arguments, we cannot dismiss the groups' concerns. We learned the hard way last time that the Black Caucuses' votes, particularly, ended up counting much higher than their actual number.

Anyway, for what it's worth -- that's my two cents.

Hate Crimes Bill Fate Uncertain

WASHINGTON (AP) -- Legislation that would broaden the federal hate crimes law by including offenses based on sexual orientation faces an uncertain future despite President Clinton's call for lawmakers to pass it this year. in the last Congress.
