CONGRESS TODAY (9/3)

SENATE

Senators D□, Amato and Moynihan introduced a bill this afternoon to disapprove the President□,s item veto of the New York Medicaid exemption. In general, the Congress has 30 session days during which to consider the disapproval bill under expedited procedures. Introduction of the disapproval bill does not, itself, impact the cancellation; the cancellation remains in effect during the 30 days. Even if Congress passes the disapproval, the President can veto the disapproval bill -- effectively requiring a 2/3 vote to disapprove the cancellation.

H.R. 2160 - Agriculture FY 1998 Appropriations bill.

o Passed (voice vote) Harkin amendment that funds the FDA/anti-tobacco initiative at \$34 million, the level requested by the Administration, with an offset from USDA computer purchases.

The Senate continued consideration of S. 1061, the Labor/HHS Appropriations Bill:

[SAP sent, 9/2: senior advisors veto threat for controversial amendments that may be offered to 1) halt funding for the President□,s national testing initiative, 2) prohibit funds for supervising the Teamster□,s election, 3) provide that welfare recipients in workfare can be paid at rates below minimum wage, and 4) direct approval of State plans that privatize the administration of public assistance programs, in addition to □&other concerns raised in the SAP.]

o Passed (unanimous consent) Dorgan amendment that increases NIH Cardiovascular research with an \$8 million offset from NIH buildings and facilities.

o Passed (unanimous consent) Specter amendment on attendant care that requires HHS to complete a study on the cost-effectiveness of allowing the disabled to remain at home and receive Medicare coverage.

o Rejected (25-74) Kyl amendment that would have cut LIHEAP by \$528 million and transfer that money to Pell grants.

o Adopted a Coats (R-IN) amendment (unanimous consent) to mandate a National Academy of Science study to determine how NIH should prioritize resources. The Senator expressed concern that the NIH and Congress was allocating too much finding to "hot" diseases or those diseases that have an active lobby/advocacy community.

o Adopted a Wellstone (D-MN)-McCain (R-AZ)-Boxer (D-CA) amendment (95-3) that authorizes the creation of a new Parkinson's Disease research program.

o Considered a Coats amendment that would ban the use of fetal tissue in the research of Parkinson's disease. Sen. Coats highlighted the uses of electively-aborted fetuses in research projects, claiming that permitting such research created a perverse incentive for the medical community to perform abortions.

Late Wednesday evening, Senator Lott filed cloture motion to proceed to the FDA bill. A vote on the motion will occur on Friday morning.

o Approved (voice vote) Traficant amendment which prevents funding for NATO expansion unless such funding has been authorized by law (by the authorizing committee).

The House rejected (202-208) a Serrano (D-NY) motion to instruct Conferees for H.R. 2209, Legislative Branch FY 1998 Appropriations, for a provision in the Senate bill, which limits the increase in the Joint Committee on Taxation to 4.64 percent.

Agreed (299-125) to a Kapter (D-OH) motion to instruct conferees on H.R. 2160, Agriculture Appropriations Bill, to agree to the Senate funding levels for a FDA program to prevent the use of tobacco products by minors.

Agreed to a motion to close the DOD conference when matters of national security are under consideration.

o Senators Gregg (R-NH) and Coats (R-IN) plan to introduce an amendment that would require that any national testing initiative be developed and administered by an independent agency. (A hearing will take place on national testing tomorrow morning at 8:30 AM. Rep. Goodling is expected to testify.) Senator Gregg claimed that this amendment is in line with the Administration position. Senator Coats offered a second degree amendment that would also require that any national testing initiative be explicitly authorized.

On Friday morning, the Senate will vote on the cloture motion to proceed to the FDA bill.

The amendment is in large part a reaction to French leader Chirac's statement that he does not want to pay for the most recent NATO expansion because of his disagreement with refusing to admit some Eastern European countries in the latest round of NATO expansion.

o Burton amendment which would not allow more than \$42 million in "Development Assistance" to go to the government of India due to human rights violations by the Indian government.

o Fox amendment which would prohibit the use of Development Assistance funds for directly supporting or promoting trophy hunting or the international commercial trade in elephant ivory, elephant hides, or rhinoceros horns.

o Torres amendment to eliminate FO funding (\$1.2 million in Foreign Operations) for the U.S. Army's School of the Americas in Fort Benning, Georgia (\$3.1 million comes from the Defense appropriations bill). The President, and many of his advisors, including General McCaffrey, support funding for the school. For the first time, the FO bill contains provisions which make funding for the School of the Americas conditional upon certification by the Secretary of Defense that the school's curriculum does not promote human rights violations (the bill also requires the Secretary of Defense, in consultation with the Secretary of State, to develop guidelines for human rights training).

o Approved (97-0) D'Amato amendment that would increase the Older Americans Act (Admin. on Aging) by \$40 million (offset by a unallocated \$40 million administrative decrease for agencies funded by the bill).

o Tabled (56-42) Kennedy 2nd-degree amendment to the Nickles amendment to prohibit the use of Federal funds on a Teamster's election. The 2nd-degree amendment would have clarified that the prohibition did not supersede the Court decree mandating Federal payment.

1. Disability: Meeting Next Week with Disability Groups, Including ADAPT -- Next Wednesday you will meet with disability advocates including ADAPT, the group that uses disruptive tactics to push its message that Medicaid should cover personal attendant services. The Office of Public Liaison committed to hold this meeting after ADAPT staged a disruption in Georgia last year. We have broadened the agenda and the attendance to include other disability advocates and issues, including the ADA, IDEA, employment, and the cutoffs of children on SSI.

ADAPT will push for your support of their bill, the Community Attendant Services Act (CASA), which would mandate coverage of community-based attendant services for those now entitled to nursing home care. Speaker Gingrich introduced CASA in June without endorsing it, instead calling it a "starting point" for dialogue and noting the cost implications. Because of the cost, we will be unable to support CASA. However, we can discuss intermediate steps we are taking to move ahead on this issue, although these are unlikely to satisfy ADAPT. Not all disability groups are strong supporters of CASA.

2. Crime: Crime Bill Anniversary -- Next Saturday will mark the third anniversary of the Crime Act. In next week's radio address to commemorate the Crime Act, we plan to release a community policing report prepared by the COPS Office and the last round of COPS universal hiring grants for the fiscal year-- bringing the total number of community police officers funded through the COPS program to over 65,000. The report highlights the achievements of your signature community policing program as well as making the case that community policing is making a difference in fighting crime. (**NOTE FOR BRUCE:** Rahm is pretty unhappy with the latest draft that we got today. He's threatened to pull the radio address if it's not improved by Monday. I'm planning on rewriting parts of it this weekend-- I wasn't sure if you still wanted to include the bullet in the weekly with this caveat.)

3. Education: Preliminary Injunction Denied in High Stakes Testing Case in North Carolina. On August 29, the United States District Court for the Eastern District of North Carolina refused to grant a preliminary injunction against a local school district policy which requires all students in grades 3 through 8 to achieve a specified score on the North Carolina state reading and math tests before they can be promoted to the next grade. Approximately 480 students have been retained as a result of the policy, which had been challenged on behalf of the NAACP Legal Defense Fund and parents of 14 of the students affected. In denying relief, the court found that the plaintiffs were “less than likely” to prevail on the merits of their claim. Department of Education staff understands that the school district is adding additional measures of student achievement for promotion purposes.
