QUESTION AND ANSWER ON WELFARE REFORM AND THE MINIMUM WAGE

Question: Is the Administration going to make clear that the Fair Labor Standards Act requires that at least the minimum wage be paid to welfare recipients participating in work activities?

Answer: This Administration is committed to moving people from welfare to work. It's also committed to making sure workers get at least the minimum wage for their efforts. Workers shouldn't be paid a subminimum wage, whether or not they come off the welfare rolls. But the Administration hasn't reached a final decision on the precise interaction between the Fair Labor Standards Act and the new welfare law. We expect to do so within the next few weeks.

I met Friday morning with 2 people from the Utah Department of Education who are responsible for the administration of their school lands, as well as someone from the Utah affiliate of the National Education Association.

They presented a lengthy history of school lands in Utah, and their efforts to generate more funds for education from them than has been the case in the past. I listened attentively. Their bottom line is that they would like to work out a way to swap the school lands inside the national monument for other school lands either inside or outside the monument (they seem to have an endless supply of options for this). They claim it is possible to do this and meet the Administration's environmental purposes while at the same time generating the revenue they believe they need and are entitled to.

I suggested to the Utah delegation that it would be appropriate -- and far more productive -- for them to meet with CEQ officials. They agreed, and I promised to try and set up such a meeting. Kathleen and Tom -- are you willing to meet with them? How would you like to proceed?

MEMORANDUM FOR THE HEADS OF EXECUTIVE DEPARTMENTS AND AGENCIES

SUBJECT: Federal Policies Targeted to Children in Their Earliest Years

Over the past few years, scientific research has demonstrated that the earliest years of life -- before children reach school-age -- are critical to cognitive, emotional, and physical development. We know that emotional nourishment, intellectual stimulation, parental and community support, good nutrition, proper health care, quality child care, and safe housing during the first years of life form the foundation for a child's ability to learn, thrive in school, work productively and contribute fully to society.

Across the federal government, we are making great strides to enhance development during the earliest years of life, before a child reaches school, by investing in research, educating parents and caregivers, and supporting programs that provide early intervention to disadvantaged families. I am committed to accelerating our efforts to target the earliest years of life. We all have a stake in ensuring that every child is given the opportunity to fulfill his or her God-given potential.

Today, I am directing the heads of executive departments and agencies to report to me in thirty days with:

1. a comprehensive list and assessment of existing projects and programs that target the earliest years of life -- including any qualitative or quantitative evidence of success, as well as current funding level and number of clients served -- and a description of proposed improvements, if any are needed, to such projects and programs;
2. a comprehensive list and assessment of planned projects and programs that target the earliest years of life, including projected funding levels and number of clients to be served; and
3. specific proposals for additional projects and programs that could be undertaken to improve the earliest years of life that do not require new spending, or that can be undertaken this year within the proposals in the FY 1998 Budget, or that could be developed for consideration for the FY 1999 Budget, within the limits of my Balanced Budget Plan.

I am also directing the establishment of a senior level interagency working group to share, examine, and develop these assessments and plans.

FYI, assuming you are thinking about whether to add this to our list of potential events: one problem that Steve and I talked about is that we would presumably want such an event to stress the welfare angle, but we don't want critics to say we are relaxing the citizenship process to keep people on welfare/SSI. (This isn't true, but they might say it.) An alternative message might be that the Administration is doing all it can within the law to naturalize eligible people with disabilities, and this will have the happy side effect of helping some of those at risk in the welfare law, but citizenship only goes so far, as it should -- that we need the President's proposal to be enacted to really help those in need.
