Heads Up -

We just circulated for clearance a Justice report strongly opposing HR 351 - Bilingual Voting Rights. The bill would repeal bilingual voting protections in the Voting Rights Act which require that voting registration, information, and other voting forms be provided in appropriate languages to service non-English proficient citizens.

The letter states that "[i]f a repeal were sent to the President, the Attorney General would recommend that he veto such legislation."

Justice (Patrick) testified on April 18, 1996, in opposition to H.R. 351 and sent a letter to the House Judiciary Subcommittee "strongly opposing" the bill on May 23, 1996.

The House Judiciary Committee is scheduled to markup HR 351 on Tuesday, June 11th. Justice would like clearance of their letter before COB today, June 7th. Therefore please provide your signoff or comments on the letter by 5pm today, June 7th.

I've taken a look at the old Federalism EO and the new Civil Justice and Unfunded Mandates EO. There's not as much direct overlap as I had hoped. The Civil Justice EO just doesn't have much to say about federalism issues. The Unfunded Mandates EO establishes a presumption against unfunded mandates and encourages regulatory waivers. The Federalism EO establishes much more general and also stronger guidelines: asking agencies to assess the justification and constitutional authority for actions impinging on states; requiring in such cases that constitutional authority be clear (rooted in a specific provision of the Constitution) and that national action be necessary; establishing a presumption against promulgating uniform, national standards and in favor of deferring to state standards and policies; reading statutes as not preempting state law unless they expressly do so, etc. We can say truthfully that the Unfunded Mandates EO goes in the same general direction. But we can't say that it (or any other EO) effectively takes the place of the Federalism EO. That being the case, I'm leery of repealing the Federalism EO at this point. I'd rather think about how agencies can comply with the EO in as non-burdensome way as possible. Perhaps there is no such thing as non-burdensome compliance and this approach would create a huge administrative problem. But I think the presumption should be in favor of trying to find a way to live with this EO rather than (now) to repeal it.

A second approach would be to grant the request to waive the entitlement, but require the State to make "best efforts" to ensure that all those eligible receive job slots. This language would confine, but not completely eliminate the State's discretion. (Similar provisions could require the State to use "good faith" in attempting to provide job slots to all eligible individuals or to show a "substantial reason" for failing to do so. Each of these formulations may have certain advantages and disadvantages, but they all accomplish the same basic thing.) Because some discretion remains, the State almost certainly could avoid the due process protections of Goldberg: recipients would get the process proposed by the State, but not a full evidentiary hearing prior to sanction. If the State failed to meet this best efforts standard, HHS would have the authority to revoke the waiver. The standard also might be enforceable through private action.
