

Dear President Clinton:

We are entirely fed-up with people like Paula Jones suing you while you are trying to work. It seems to us that none of these civil suits can proceed in the face of the Soldiers' and Sailors' Civil Relief Act of 1940 (50 U.S.C. Appen. Section 501 et seq.). As Commander in Chief of the Armed Forces, you are on active duty twenty-four hours a day and will be until the end of your term, or hopefully, terms. You are thus entitled to all of the same protections as any other active duty member of the American Armed Forces. We assume that your able legal counsel have already thought of this. If not, perhaps they will find this suggestion helpful.
