Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2006-0320-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2006-0320-F (seg 1) contains material pertaining to the investigation of Whitewater Development Corporation and Madison Guaranty Savings and Loan. The records focus on Whitewater, Madison Guaranty, Vincent Foster, and the White House Travel Office (Travelgate). Whitewater was the name given to a failed 1970s Arkansas real estate venture, in which then Governor Bill Clinton, and his wife, Hillary Rodham Clinton, were partners. Whitewater was backed by Madison Guaranty Savings and Loan, which went bankrupt in 1989.

The WHORM Subject files for Whitewater contain twenty-two subject file categories. These categories contain correspondence, memoranda, resumes, fact sheets, magazine and newspaper articles. The correspondence records contain material from the White House Counsels office, the Office of the Attorney General, Congressmen, Senators, Senate Special Committee to Investigate Whitewater,

Committee on Banking Housing and Urban Affairs, the Office of the Independent Counsel, various television networks, newspaper and magazine reporters, and letters in support of the President. The memoranda files contain material from the United States District Court, Senate Special Committee to Investigate Whitewater, White House Office of Records Management, copies of subpoenas and subpoena riders requesting documents relating to the Whitewater investigation, memoranda between staffers, copies of portions of some of the Senate hearings, statements, and guidance of White House policies that relate to Whitewater. The resumes are from private attorneys who wish to assist the President. The fact sheets cover the chronology, history, and background of Whitewater and Madison Guaranty. The magazine and newspaper articles relate to Whitewater, Madison Guaranty, the Rose Law Firm, Resolution Trust Corporation (RTC), Vincent Foster, and the White House Travel Office. The documents include news summaries, testimonies, copies of some transcripts, some statements, and Questions and Answers that all relate to Whitewater.

The White House Staff and Office Files for Whitewater contain correspondence, memoranda, reports, press releases, and newspaper articles relating to the investigation of Whitewater Development Corporation and Madison Guaranty. The correspondence records contain material from Office of the Independent Counsel, The Attorney General, Department of Justice, House of Representatives, the White House Counsel's Office, the Resolution Trust Corporation, the Federal Deposit Insurance Corporation, the Small Business Administration, Senate Special Committee, Treasury Department, Senators, Congressmen, legal representatives, and White House staff. The memoranda contains material from the grand jury relating to subpoenas, the White House Counsel's Office, White House staff, the House of Representatives, the Resolution Trust Corporation, the Attorney General's Office, the Small Business Administration, the Banking Minority Staff, Senators, Congressmen, attorneys, White House staff, and the press. The reports contain material that detail Whitewater and Madison Guarantys activities and accounts and they include charts, graphs, and timelines. They include the Minority Report of the Special Committee to Investigate Whitewater Development Corporation and Related Matters, Pillsbury Madison & Sutro reports prepared for the Federal Deposit Insurance Corporation, the Lyons Report, Minority Views of the Special Committee to Investigate Whitewater: Summary of Conclusions, Hearing of the Senate Whitewater Special Committee: Statements from various Senators, Senate Banking Committee Report, Final Report of the Special Committee to Investigate Whitewater Development Corporation and Related Matters, Committee on Banking and Financial Services, Housing and Urban Affairs, U.S. Senate Republican Policy Committee – Issue Updates, Senate Resoultion 120, Office of the Independent Counsel report, and transcripts of the proceedings. The press releases and questions relate to all matters concerning the President and Mrs. Clintons involvement with Whitewater and Madison Guaranty, various reports, and the investigation of Whitewater and Madison Guaranty. The newspaper articles contain material that covered the history and chronology of Whitewater and Madison Guaranty, portions of the hearings, the various committee reports, the cost of the investigations, and the people that were involved. The files also contain copies of documents that were requested for the investigation by the Senate Special Committee to Investigate Whitewater, Office of the Independent Counsel (OIC), House Banking Committee, Federal Bureau of Investigation (FBI), and the Resolution Trust Corporation. Included are documents from the Rose Law Firm, Madison Guaranty Savings and Loan, Madison Financial Corporation, Madison Marketing, Whitewater Development Corporation, Resolution Trust Corporation, International Paper Realty Corporation, Great Southern Land Company, Small Business Administration, Security Bank, Worthen Bank, Citizens Bank and Trust of Flippin Arkansas, Madison Bank and Trust, Perry County Bank, Arkansas Securities Department, Flowerwood Farms, Industrial Development Corporation (IDC), Office of Thrift Supervision, Ozark Realty Company, Maple Creek Farms, Castle Grande, transcripts from early court proceedings, the Clinton Campaign, Federal Savings and Loan Insurance Corporation, Federal Home Loan Bank Board, and Federal Home Loan Bank Board reports.

The NSC Cable and Email Systems contain records relating to document requests and subpoenas.

The NSC Records Management System contains memoranda relating to document requests by the Senate Special Committee.

System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas – Clinton Presidential Records: WHORM Subject Files, Clinton Presidential Records: White House Staff and Office Files, Clinton Presidential Records: NSC Cable, Email, and Records Management Systems.

Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
