Access

Provenance

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed by

Staff Archives Specialist, 2009-2010. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2006-0469-F (seg 1) are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

Michael Waldman was Assistant to the President and Director of Speechwriting from 1995-1999. His responsibilities were writing and editing nearly 2,000 speeches, which included four State of the Union speeches and two Inaugural Addresses. From 1993 -1995 he served as Special Assistant to the President for Policy Coordination. He is now executive director of the Brennan Center for Justice at NYU School of Law.

FOIA request 2006-0469-F consists of copies of speeches and speech drafts, talking points, memoranda, background material, correspondence, reports, handwritten notes, articles, clippings, and presidential schedules. Most of the material contained in this collection was used to assist in writing speeches. A large volume of this collection was for the State of the Union speeches. Many of the speech drafts are heavily annotated with additions or deletions. There are a lot of articles and clippings in this collection.

System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas – Clinton Presidential Records: Staff and Office Files.

Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
