Scope and Content

The materials in FOIA 2008-0212-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

Daniel Seals, the son of a former Chicago Bears football player, was raised in Illinois. After graduating college he spent a period teaching English in Japan. Following his return to the United States he studied International Economics and Japanese Studies in Johns Hopkins University's School of Advanced International Studies. Seals received a Master's degree from Johns Hopkins University in 1997 and was nominated for a Presidential Management Internship. During his internship Seals served as an Aide to the Assistant Secretary of Commerce and as an economic fellow for the United States Senate.

After leaving his internship, Seals returned to school at the University of Chicago and began working in a number of economics and consulting jobs. In 2006, 2008, and 2010, Seals was unsuccessful at winning the 10th District U.S. congressional seat. Seals was named Assistant Director of the Illinois Department of Commerce and Economic Opportunity in May 2011.

Clinton Presidential Records relating to Dan Seals consist of Automated Records Management [Email].

Automated Records Management System [Email] (ARMS) e-mail records responsive to this FOIA originate in the Office of the White House (WHO) and Default e-mails belonging to no specific agency. These e-mails consist primarily of correspondence between staff regarding Seals application for an Internship and between Seals and Sue Bachtel, Special Assistant to the Director of the Office of Science and Technology Policy, regarding a possible full or part-time position.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection—Clinton Presidential Records: Automated Records Management System [Email].

The Automated Records Management System (ARMS) is a database that contains email records of the Executive office of the President. This system maintained unclassified Presidential record email. The ARMS dataset is comprised of 6 sub-series of email records called “Buckets.” The buckets include NPR, OPD, POTUS, WHO, CEA, and Default. ARMS emails are arranged chronologically by creation date.
