Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Provenance

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2008-1390-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2008-1390-F consists of correspondence to, from, or about Dr. James Benito Hall, who served as Ambassador of Goodwill, HIV/AIDS.

System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas – Clinton Presidential Records: WHORM Alpha File and Clinton Presidential Records: Staff and Office Files.

The WHORM Alpha file was compiled by the White House Office of Records Management from 1993-1996 and is a series of documents arranged by names of persons, organizations, or events.

Staff and Office files were maintained at the folder level by staff members within their individual office and document all levels of administration activity.

WHORM files are processed at the document level: whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
