WEEKLY REPORT TO THE WHITE HOUSENATIONAL CONSUMERS WEEK

October 25 - 30 is National Consumers Week. Our theme is Focus on Fraud." We will hold a press conference on Tuesday, October 26 where Hubert Humphrey III will announce a multi-state effort to crack down on consumer fraud. We will announce our new fraud fighters guide for consumers, available from the Consumer Information Center in English, Spanish, Korean and Chinese.

Howard Seltzer, our Acting Deputy Director, has done numerous interviews in response to our media campaign.

LOU HARRIS POLL ON HEALTH CARE PRIVACY

On Friday, October 29 we will hold a conference surrounding the release of a new Lou Harris poll on privacy in health care.

PRIVACY ADVOCATE/HHS MEETING

On October 20 I chaired a meeting between privacy advocates and senior staff within HHS who supported the health care reform effort. Privacy advocates main points were that corporate self-insured plans would continue to have an incentive to know the particulars about an employees health record and that it is dangerous to use a social security number as an identifier. Also, they called for a federal law to govern medical records.

INFORMATION INFRASTRUCTURE TASK FORCE

On October 21, I chaired a meeting of the IITF Working Group on Privacy. Speakers Dr. Alan Westin and Dr. Eli Noam were the guests. The group has decided to hold public hearings and reach out through electronic means to get input into the process.

ACTIVITIES OF PAUL STEVEN MILLER

On October 29, Consultant Paul Steven Miller, along with David Horowitz, will be interviewed on the Michael Jackson radio show in Los Angeles. The subject will be direction of USOCA in the Clinton Administration and consumer fraud.

On November 5, he will participate in a NAFTA briefing for consumer leaders which is being coordinated by the U.S. Department of Commerce and the National Coalition for Consumer Education.

On October 20, Mr. Miller met with Governor Mike Lowry of Washington State and other disability leaders to discuss disability issues.

Other meetings on disability rights issues included a meeting with international disability leaders visiting Washington from Japan, Australia, New Zealand, etc. and a meeting with Adelaide Farrah, representative of the Organization of American States. The latter meeting was held to discuss ways in which the U.S. can participate and provide leadership in disability rights and education programs occurring in the OAS.
