Alissa Brown was a staffer in the First Lady's office in the Old Executive Office Building who kept files on Hillary Rodham Clinton's public statements, speeches, and writings. This collection consists of background information on former First Ladies, copies of Hillary Clinton's speeches, news articles covering Mrs. Clinton's role as an advocate for children's issues and briefing papers on select administration policies.
