Summary

This collection consists of records related to the senate confirmation of George Z. Singal. Singal was a federal judge in the United States District Court for the District of Maine. He was nominated to the court by President Clinton on May 11, 2000 and was confirmed by the Senate on June 30, 2011. Mr Singal practiced law from 1970 until his appointment to the bench. This collection consists of correspondence, memoranda, resumes and and personal data questionnaires. Most of the correspondence consists of recommendation letters for George Z. Singal's appointment to the bench.

Scope and Content Note

The materials in FOIA 2009-0898-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. WHORM Subject files material, found to be responsive to this FOIA, contain correspondence, memoranda, and a resume. White House Staff and Office Files material, found to be responsive to this FOIA, are from the records of the White House Counsel's Office and Presidential Personnel. They consist of correspondence, memoranda, resumes, and personal data questionnaires. Most of the correspondence consists of recommendation letters for George Z. Singal's appointment to the bench.

Biographical Note

George Z. Singal was born in Florence, Italy in 1945 in a Italian refugee camp. He was naturalized in 1956 in Bangor, Maine. He graduated from the University of

Maine in 1967 and received his law degree from Harvard Law School in 1970. He is a federal judge in the United States District Court for the District of Maine. He was nominated to the court by President Clinton on May 11, 2000 and was confirmed by the Senate on June 30, 2000. Mr Singal practiced law from 1970 until his appointment to the bench.

System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas – Clinton Presidential Records: WHORM Subject Files, Clinton Presidential Records: Staff and Office. The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject File was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. WHORM files are processed at the document level; whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. FOIA 2009-0898-F includes WHORM records from these subject codes: FG Federal Government - Organizations.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
