Summary

This collection consists of records related to Congressional correspondence to the White House during the Clinton Administration. It primarily includes tracking reports for incoming Congressional correspondence

Scope and Content Note

The materials in FOIA 2007-1469-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. This collection largely consists of daily and weekly reports regarding correspondence from members of Congress. It includes documents from Legislative Affairs titled "Congressional Mail Received." These reports identify the date range for the receipt of correspondence, identify the member(s) of Congress who authored the correspondence, and provide a summary of the correspondence. Some "Congressional Mail Received" reports also provide statistics for records and documents. The primary date ranges for "Congressional Mail Received" reports are as follows: January 1, 1994 to April 12, 1994; November 3, 1995 to December 19, 1995; and April 2, 1999 to September 28, 1999. Also responsive to this collection are Weekly Congressional Tracking Reports for Presidential Correspondence. These reports are congressional correspondence forwarded from Legislative Affairs to the National Security Council (NSC). The reports identify the member(s) of Congress who authored the correspondence and provide a summary of the correspondence. These Congressional Tracking Reports 2007-1469-F <http://www.clintonlibrary.gov> 2 also provide statistics for congressional correspondence. The date ranges for these reports range from March 16, 1993 to June 10, 1997. The records of the National Security Council also contain reports of "overdue" correspondence in the system. These documents list the author and subject of the correspondence, as well as the

NSC action officer, the due date, and the NSC Records Management System log number.

Records that are responsive to this FOIA request were found in these collection areas - Clinton Presidential Records: White House Office of Records Management (WHORM) Subject Files and Clinton Presidential Records: White House Staff and Office Files. The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. Staff and Office Files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. WHORM files are processed at the document level; whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. FOIA 2007-1469-F includes WHORM records from this subject code: WH004-01 White House Mail Reports

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
