Summary

This collection consists of material regarding the appointment of Laurence Meyer to the Board of Governors of the Federal Reserve System. President Clinton nominated Meyer to that Board in 1996 and he served as a Governor on the Board from June 1996 to January 2002. The collection contains memoranda on Meyer's economic forecasting business and also his nomination to the Board of Governors, correspondence and publications reviewed for Meyer's appointment, and a draft of Meyer's opening statement for his confirmation hearing.

Scope and Content Note

The materials in FOIA 2015-0239-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. The records in this collection regard the appointment of Laurence Meyer to the Board of Governors of the Federal Reserve System. President Clinton nominated Laurence Meyer to the Federal Reserve Board of Governors in 1996. Meyer served as a Governor on the Federal Reserve Board from June 1996 to January 2002. Memoranda in the WHORM Subject File concern Meyer's economic forecasting business and nomination to the Board of Governors. White House Counsel's Office materials include correspondence and publications reviewed for Meyer's appointment. Also included is a draft of Meyer's opening statement for his confirmation hearing.

System of Arrangement

Records that are responsive to this FOIA request were found in these collections areas— Clinton Presidential Records: White House Office of Records Management (WHORM) Subject Files and Clinton Presidential Records: White House Staff and Office Files. The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. WHORM files are processed at the document level; whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. FOIA 2015-0239-F includes WHORM records from these subject codes: FG001 President of the United States FG143 Federal Reserve System, Board of Governors

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
