**Summary**

This collection consists of material regarding Edward Gramlich's appointment to the Federal Reserve System's Board of Governors in 1997, from which he resigned in 2005. This collection contains correspondence and personnel materials regarding Gramlich's nomination, confirmation, and appointment to the Senate, in addition to publications mentioning Gramlich.

**Scope and Content Note**

The materials in FOIA 2015-0241-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This collection contains records regarding Edward Gramlich's appointment to the Federal Reserve System's Board of Governors in 1997. Gramlich resigned from the Federal Reserve System in 2005. Prior to his appointment, Gramlich was a professor of economics at the University of Michigan. Earlier in his career, he was a senior fellow at the Brookings Institution and a research economist for the Federal Reserve. This collection contains correspondence and personnel materials regarding Gramlich's nomination, confirmation, and appointment by the Senate. The collection also contains publications mentioning Gramlich. Edward Gramlich died on September 5, 2007.

**System of Arrangement**

Records that are responsive to this FOIA request were found in these collections areas— Clinton Presidential Records: White House Office of Records Management (WHORM) Subject Files and Clinton Presidential Records: White House Staff and Office Files. The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. WHORM files are processed at the document level; whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. ## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C.
