Summary

This collection consists of records from the White House Counsel's Office relating to the selection of judicial candidates. President Clinton successfully appointed 66 judges to the United States Courts of Appeals and 305 judges to the United States District Courts. The files contain correspondence, memoranda, profiles, resumes, reports, news articles, and copies of court cases. The records include material on the judicial appointments process, reports on judges for reappointment, numerous letters of recommendations, and candidate questionnaires.

Scope and Content Note

The materials in FOIA 2007-0561-f are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA request 2007-0561-F contains records from the White House Counsel's office relating to the selection of judicial candidates. The records contain correspondence, memoranda, profiles, resumes, reports, forms and news articles. These records include material on the judicial appointments process, reports on judges for reappointment, Personal Data Questionnaires, Senate and Judicial Questionnaires, Office of the Attorney General Questionnaires, and numerous letters of recommendations. They also contain copies of court cases, decisions, and opinions. President Clinton nominated 45 people for 42 different federal district court judgeships who never were confirmed by the U.S. Senate. Many of the nominees were blocked by Republicans either in the Senate Judiciary Committee or on the Senate floor. The Senate Judiciary Committee was controlled by Republicans for six of the eight years of Clinton's presidency. While in office President Clinton did successfully appoint 66 judges to the United States Courts of Appeals and 305 judges to the United States district courts.

System of Arrangement

Records responsive to this FOIA request were found in this collection area—Clinton Presidential Records: White House Staff and Office Files Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
