## **Summary**

This collection consists of records dealing with the fundraising and campaign finance scandals associated with the Lippo Group and three Chinese businessmen—John Huang, Johnny Chung, and Yah Lin “Charlie” Trie. The collection contains memorandums, emails, timelines, correspondence, lists, agendas, schedules, records of attendance, transcripts, and handwritten notes. The collection also includes materials produced for House and Senate investigations.

## **Scope and Content Note**

The materials in FOIA 2008-0825-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2008-0825-F contains records dealing with the fundraising and campaign finance scandals associated with the Lippo Group, an overseas conglomerate established in 1950, and three businessmen—John Huang, Johnny Chung, and Yah Lin “Charlie” Trie. The White House Office of Records Management (WHORM) Subject Files contain a number of records relating to the campaign finance scandal in 1996. There are materials describing gifts President Clinton received from Huang, Chung, and Trie and correspondence concerning gifts he sent to the three men. Included are numerous letters from members of Congress wondering if Clinton could get them to appear before investigative committees. WHORM documents also include records related to potential appointments to commissions. The White House Staff and Office Files in the case of this FOIA are almost entirely from the Counsel’s Office. The collection includes files from Cheryl Mills, Lanny Breuer, Michael Imbroscio, Sally Paxton, Erin Peterson, Karl Racine and others. Documents include memorandum, emails, timelines, correspondence, lists, agendas, schedules, records of attendance, transcripts, and handwritten notes. Records of attendance show

whether or not Trie, Huang, or Riady were present at specific meetings; handwritten notes of Trie record information about the meetings. The collection also includes materials produced for House and Senate investigations. These materials include records related to the Democratic National Committee and political fundraising activities. Memoranda, lists, notes, reports, flyers, forms, and correspondence document fundraising activities. Most prominent are lists of people attending functions, accompanying memos outlining how these events will take shape, and additional memos regarding DNC financial updates and available media funds. It should be noted that a large portion of the material in this collection has been designated "nonrecord" and is closed.

Founded in Indonesia, the Lippo Group expanded operations into the United States in an effort to increase their holdings. The organization became especially prominent on America's west coast, with Huang landing a position at the Lippo Bank in California. Implicated in major campaign finance violations, senior officials in the Lippo Group (such as James Riady) were ordered to pay hefty fines. Huang found himself at the center of the fundraising scandal connected with the 1996 presidential campaign. President Clinton appointed him to the post of deputy assistant secretary for international economic affairs in the Commerce Department in December 1993. Huang eventually became a key fundraiser for the DNC (Democratic National Committee) and worked with influential figures and grassroots members, getting them to donate millions to the party. One of the controversial fundraising activities involved the Hsi Lai Buddhist Temple in California. Huang was sentenced to one year of probation and the U.S. District Court fined him \$10,000 and required him to perform 500 hours of community service.

A native of Taiwan, Johnny Chung came to Washington, D.C. in the early 1990s. During the two-year period of 1994-1996 Chung donated large sums of money to the DNC. Eventually all of this money was returned. Chung agreed to plead guilty to bank fraud, tax evasion, and two misdemeanor counts of conspiracy to violate election law. He received a sentence of 5 years of probation and 3,000 hours of community service. "Charlie" Trie came to the United States from Taiwan in 1974. His friendship with the then governor of Arkansas began in a restaurant he co-owned in Little Rock. His most important campaign activities revolved around a donation of \$450,000 he made to the President's Legal Defense Fund and a contribution of \$220,000 he and his immediate family directed to the DNC. All of this money (\$670,000) was returned over the course of a few months. Trie left the country when Congressional investigations were looming in 1996. He came back to the U.S. two years later and was convicted of violating federal campaign finance laws. He was sentenced to four

months of home detention and three years of probation.

## **System of Arrangement**

Records that were responsive to this request were found in these collection areas—Clinton Presidential Records: WHORM Alpha Project; Clinton Presidential Records: WHORM Subject Files; Clinton Presidential Records: White House Staff and Office Files; Clinton Presidential Records: Automated Records Management System [Email]; and Clinton Presidential Records: NSC Cable, Email, and Records Management System. The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Alpha file was compiled by the White House Office of Records Management from 1993 – 1996 and is a series of documents arranged by name of persons, organizations, or events. The WHORM Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. In addition, there are WHORM, WHORM Counsel, WHORM (CL), WHORM (OP), WHORM (Too Late); WHORM (Various Offices); and WHORM (Alpha Project) series. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. WHORM files are processed at the document level; whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. The Automated Records Management System (ARMS) is a database that contains email records of the Executive Office of the President. This system maintained unclassified Presidential email. The ARMS database is comprised of six sub-series of email records called "buckets." The buckets generally represent a specific White House office. The buckets are titled: NPR for National Performance Review, OPD for Office of Policy Development, POTUS for President of the United States, WHO for White House Office, CEA for Council of Economic Advisers, and Default for emails not

associated with an office. The NPR bucket contains email created or received by an individual with a National Performance Review (NPR) White House user account. The OPD bucket contains email created or received by an individual with an Office of Policy Development (OPD) White House user account. The POTUS bucket was designated for email created and received by the President of the United States (POTUS). Please note that President Clinton never used his POTUS White House user account to send the few emails he wrote while in office. The WHO bucket contains email created or received by individual with an Executive Office of the President White House user account not identified as CEA, NPR, or OPD. The CEA bucket contains email created or received by an individual with a Council of Economic Advisors (CEA) White House user account. The Default bucket contains email created or received by unknown or un-recognized email accounts. Email found within the Default bucket often includes email created or received by offices or individuals outside the Executive Office of the President. ARMS emails are arranged by topic, there-under by bucket, and there-under chronologically by creation date.
