## **Summary**

This collection is the tenth segment of materials related to the Health Care Task Force. It includes the files of Robert Boorstin, Alice Dunscomb and the Health Care Delivery Room Central Files, also referred to as the General Files. The collection contains calendars, correspondence, memoranda, newsletters, polls, reports, statements, talking points, and drafts of Health Care Economics, Health Care Reform and the Health Security Act. The General Files primarily contain clippings regarding various issues associated with the Health Care Task Force as well as advertisements, analysis, articles, correspondence, draft legislation, fact sheets, legislative summaries, notes, position papers, press releases, publications, reports, scheduling materials, statements, tables, talking points, testimonies, and transcripts.

## **Scope and Content Note**

The materials in FOIA 2006-0885-F Segment 10 are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This collection includes the files of Robert Boorstin, Alice Dunscomb and the Health Care Delivery Room Central Files, also referred to as the General Files. Robert Boorstin spent more than 25 years working in national security, political communications, research and journalism. He served for more than seven years with the Clinton administration, acting as the president's national security chief speechwriter, health care communications director, and an adviser to Treasury Secretary Robert Rubin and Secretary of State Warren Christopher. Prior to coming to the White House Boorstin was a reporter for the New York Times. After leaving government Boorstin helped start the Center for American Progress, where he established and ran the program on national security. He was also a director of public policy in the Washington office of Google, where he led the company's efforts

on Internet freedom. Boorstin's records consist of calendars, correspondence, memoranda, newsletters, polls, reports, statements, and talking points. These records concern interest groups representing business, education, health care providers, health coalitions, patients, seniors, substance abuse, and other areas of interest. Alice Dunscomb worked in a research position for the White House during the Clinton administration from January 1993 to May 1993 on the Health Care Task Force. Ms. Dunscomb's records contain reports and drafts of Health Care Economics, Health Care Reform and the Health Security Act. The Health Care Delivery Room Central Files, also referred to as the General Files primarily contain clippings regarding various issues associated with the Health Care Task Force. The General Files also contain other reference material including advertisements, analysis, articles, correspondence, draft legislation, fact sheets, legislative summaries and analysis, notes, position papers, press releases, publications, reports, scheduling materials, statements, tables, talking points, testimonies, and transcripts

## **System of Arrangement**

Records that are responsive to this FOIA request were found in these collection areas—Clinton Presidential Records: Clinton Presidential Records: White House Staff and Office Files. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended)

and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
