## **Summary**

This collection consists of photographs from movie screenings during Clinton administration. The photographs include various screenings of movies in the Family Theatre, East Room and Camp David during the years of the Clinton administration. The photos include President Clinton and others meeting and greeting before these events.

## **Scope and Content Note**

The materials in FOIA 2016-0595-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. FOIA 2016-0595-F is a request for White House photographs pertaining to movie screenings that President Clinton and guests attended at the White House and Camp David. This request contains photographs from the White House Photograph Office. The photographs include: March 12, 1994: President Clinton and Hillary Rodham Clinton visiting with guests outside the Family Theatre prior to viewing a movie. April 15, 1994: President Clinton and Hillary Rodham Clinton greeting William "Bill" Kennedy, Strobe Talbott, Gene Sperling, Lisa Caputo, William Galston and others outside the Family Theatre. June 2, 1995: President Clinton and Hillary Rodham Clinton greeting guests at the "Crimson Tide" movie screening in the Family Theatre. June 8, 1995: President Clinton hosting an "Apollo 13" movie screening in the Family Theatre. Guests attending the screening include: Ron Howard, Lew Wasserman and others. May 2, 1996: President Clinton hosting a screening for the movie "Chicano" in the Family Theatre. Guests attending the screening include: Sec. Federico Pena, Sec. Henry Cisneros and others. January 11, 1998: President Clinton and Hillary Rodham Clinton hosting a screening of "Good Will Hunting" at Camp David. President Clinton and Hillary Rodham Clinton greet and

meet with Robin Williams, Gwyneth Paltrow, Ben Affleck, Matt Damon, Sec. Madeleine Albright and others at the screening. January 24, 1998: President Clinton and Hillary Rodham Clinton greeting guests at a screening for the movie "The Apostle" outside the Family Theatre. Guests attending the screening include: Robert Duvall, Farrah Fawcett, Harry Thomason and others. Robert Duvall addresses the screening in the Family Theatre. March 5, 1998: President Clinton and Hillary Rodham Clinton hosting an HBO screening of "From the Earth to the Moon" in the East Room. President Clinton and Tom Hanks address the movie screening. President Clinton talks with John F. Kennedy, Jr. and Carolyn Bessette Kennedy in the Blue Room and the Cross Hall before the screening. April 24, 1998: President Clinton hosts a "Dangerous Beauty" movie screening in the Family Theatre. Guests attending the screening include: Rep. Lois Capps, Don Baer, Mark Katz and others. May 12, 1999: President Clinton visiting with Robert Altman, Lynda Carter and others in the Family Theatre before a movie screening. June 10, 1999: President Clinton greeting guests outside the Family Theatre before a movie screening. August 5, 1999: President Clinton greeting Terry McAuliffe and others outside the Family Theatre before a movie screening. October 14, 1999: President Clinton hosts a "Three Kings" movie screening in the Family Theatre. President Clinton greeting guests outside and inside the Family Theatre. October 23, 1999: President Clinton and Hillary Rodham Clinton greeting guests at movie screening outside the Family Theatre. Harvey Weinstein delivers remarks at the screening in the Family Theatre. December 3, 1999: President Clinton greeting Denzel Washington, Hurricane Carter, Dan Synder and others at a screening for the movie "Hurricane" in the Family Theatre. February 12, 2000: President Clinton greeting Prince Bandar, Dale and Betty Bumpers and others at a screening for the movie "Eye of the Beholder" in the Family Theatre. February 17, 2000: President Clinton greets Sen. John Glenn, Carolyn Staley, Kris Engskov and others at a screening for the movie "The Height of the Sky" in the Family Theatre. April 7, 2000: President Clinton addresses a screening of the PBS Documentary series "The American President" on the State Floor. Guests at the screening include: Ben Bradlee, Walter Cronkite and others. June 9, 2000: President Clinton hosts a movie screening and greeting Sec. Andrew Cuomo, Lynda Carter, Robert Altman and others guests outside the Family Theatre. June 17, 2000: President Clinton hosts and greets guests at a screening for the movie "Shanghai Moon" in the Family Theatre. July 7, 2000: President Clinton greets guest for a movie screening outside the Family Theatre. September 22, 2000: President Clinton and Hillary Rodham Clinton hosting a screening of the movie "Men

of Honor” in the Family Theatre. October 27, 2000: President Clinton greeting Barbara Streisand, James Brolin, John Podesta, Erskine Bowles and others at a screening for the movie “Pay It Forward” in the Family Theatre. During the processing at the contact sheet level, additional photographs were processed such as: President Clinton attending meetings, receptions, greeting staff and radio address guests, interviews and a phone call from the Usher's Office. ## **System of Arrangement**

Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
