Summary

This collection is the twelfth segment of materials related to the Health Care Task Force. It includes the files of Robert Boorstin, Alan Hoffman, Marjorie Tarmey, Simone Reuschemeyer, and Susannah Wellford as well as some material from the General Files and Health Care Interns. The files contain briefing materials, chron files, correspondence, legislation, press materials, scheduling materials, and speeches. Subjects covered include various aspects of Clinton health care reform and health-related issues.

Scope and Content Note

The materials in FOIA 2006-0885-F (Segment 12) are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This collection includes files from the records of Robert Boorstin, General Files, Health Care Interns, Alan Hoffman, Marjorie Tarmey, Simone Reuschemeyer, and Susannah Wellford. Background information on Boorstin, Tarmey, and Reuschemeyer appears in earlier segments of this FOIA. Many listed folders have already been processed in earlier segments of this FOIA which are open and available for research. Most of the open material is in Segments 2 and 3. Boorstin's records consist of calendars, case studies, charts, correspondence, legislation, memoranda, newsletters, polls, presentations, Q&As, reports, speeches, statements, and talking points dealing with various aspects of health care to include internal and external messaging, privacy, rationing, and women's issues. The General Files contain articles, correspondence, draft legislation, fact sheets, legislative summaries and analysis, manuals, news clips, notes, position papers, press releases, publications, reports, schedules, statements, tables, talking points, testimonies, and transcripts. Subjects include computer operation, long term and

managed care, rural health, statistics, tobacco, and welfare reform. The files of the Health Care Interns contain analysis, articles and op-eds, drafts, legislation and markups, and news clips. Subjects include African Americans, Americorps, insurance lobby, Latinos, Nixon bill, polling and seniors. Alan Hoffman served in Health Care Task Force scheduling, January 1993-September 1994. Hoffman's records in this segment consist of a chronological file of health care speaking invitations from organizations and companies that were regretted. The time period covered is March - May 1994. The records are mostly letters and faxes. Reuschmeyer's records consist of analysis, database input forms and printouts, faxes, informational packets, legislation, letters, lists, memoranda, Q&As, reports, schedules, and talking points. Subjects include academic health centers, congressional districts, the Dole plan, Indian health services, malpractice, Medicaid and Medicare, media involvement, older Americans, personal stories, public and rural health, and veterans. Tarmey's records are almost exclusively informational GAO [Government Accounting Office] printed reports and testimony from 1988-1993. They include a wide variety of health care related subjects and were probably used as reference material. Susannah Wellford worked as a member of the Health Care War Room staff, January 1993-November 1994. Wellford planned health care events for the President and First Lady as well as organized speaking engagements for cabinet and congressional health care surrogates. Her records consist of calendars, contact information, faxes, letters, lists, press releases, scheduling requests, and other support material. Subjects include business issues, complaints, long term care, personal stories, the uninsured, and women's and youth issues. The chronological files in this collection cover January 16 - May 31, 1994.

System of Arrangement

Records that are responsive to this FOIA request were found in these collection areas—Clinton Presidential Records: Clinton Presidential Records: White House Staff and Office Files. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration

activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
