Summary

This collection consists of the Chron Files of Robert Bell, Special Assistant to the President for National Security Affairs and Senior Director for Defense Policy and Arms Control, National Security Council (NSC). The files contain records related to a number of military and weapons proliferation issues including policy discussions on the drafting of Presidential Decision Directives (PDD) as well as records related to treaties on landmines, Nonproliferation (NPT), and the Conventional Test Ban Treaty (CTBT). The collection also includes interagency working group documents on chemical weapons issues and the chemical weapons convention (CWC). The files also contain records that relate to the operations of the military and military policy, the Defense Base Closure and Realignment Commission (BRAC), and the National Security Telecommunications Advisory Committee (NSTC).

Scope and Content Note

The materials in FOIA 2016-0152-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. Freedom of Information Act (FOIA) request 2016-0152-F was for the Chron Files of Robert Bell, Special Assistant to the President for National Security Affairs and Senior Director for Defense Policy and Arms Control, National Security Council (NSC). Many National Security Council directorates maintained Chronological, or Chron, files as part of their record keeping. These files are collections of records on which that directorate, or a particular staff member, gave advice or held some role in drafting. They are maintained in order by date. This collection dates from 1993 to 1994. It includes a number of copies of records from the George H. W. Bush library that were retained for continuity between administrations. The Defense Policy and Arms Control directorate of the NSC during the Clinton administration dealt primarily

with issues related to United States military or to non-proliferation issues. This wide ranging collection deals with a number of military and weapons proliferation issues. It includes policy discussions on the drafting of Presidential Decision Directives (PDD) as well as records related to treaties on landmines, Nonproliferation (NPT), and the Conventional Test Ban Treaty (CTBT). The collection includes interagency working group documents on chemical weapons issues and the chemical weapons convention (CWC). The collection includes a significant number of correspondence from Congress to either the President, Anthony Lake, or Samuel Berger. Likewise the collection contains presidential correspondence to the Senate on nominations to the office corps. There are a number of records that deal with the administration's policies of the operations of the military. The issue of homosexuals in the military appears often in the collection. Bell and his staff reviewed military procurement, created minutes, agenda, papers related to meetings with joint chiefs; and correspondence from the Secretary of Defense to the President. The collection contains a number of Legislative Referral Memorandum (LRM) on proposed legislation or testimony to be given before congressional committee. Legislation related particularly to the military. Records included relate to the military operations in Somalia and in Haiti. They include approvals for Significant Military Exercises. The collection includes records related to the Defense Base Closure and Realignment Commission (BRAC). It also includes records related to the National Security Telecommunications Advisory Committee (NSTC). A small portion of the collection is simply administrative paperwork related to the operation of the directorate. Robert Bell, or Bob, has served a long and distinguished career in service of the United States. A veteran of the United States Air Force, Bell served as a staff member for the Senate Committee on Foreign Relations and the Senate Committee on Armed Services. He also worked in the office of Senator Samuel Nunn. In January 1993, Bell was hired to the NSC. He served on the NSC staff until 1999 when he was appointed as North Atlantic Treaty Organization (NATO) Assistant Secretary General for Defense Investment. Bell served in NATO positions during both the George W. Bush and Barack Obama presidencies. He was most recently Senior Civilian Representative of the Secretary of Defense in Europe (SECDEFREPEUR) and the Defense Advisor (DEFAD) to the U.S. Ambassador to NATO. He stepped down in January 2017.
