Summary

The photographs processed in this collection are related to President Jean-Bertrand Aristide of Haiti. The bulk of the material is leading up to the re-installment of Aristide as President of Haiti and the subsequent Summit of the Americas, with some small material encompassing the time period following his tenure in office.

Scope and Content Note

The materials in FOIA 2018-0084-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. FOIA request 2018-0084-F contains photographs of President Jean-Bertrand Aristide of Haiti. President Aristide had been exiled from Haiti following a military coup d'état in 1991. He was returned to power on October 15, 1994, where he remained in office until February 7, 1996. His second term as President would occur following the Clinton Administration being in office. Events include meetings at the White House both prior to President Aristide's reinstallation and following his serving of term, speeches & meetings during the September 1994 reinstallation as President, the 1994 Summit of the Americas, and a transition ceremony in 1995. Key individuals include President William Jefferson Clinton, President Jean-Bertrand Aristide, First Lady Hillary Rodham Clinton, Vice President Albert "Al" Gore, Jr., Tony Lake, Samuel "Sandy" Berger, Secretary of State Warren Christopher, Madeleine Albright, Les Aspin, Leon Fuerth, David Gergen, George Stephanopoulos, and General John Shalikashvili, among others. The December 1994 Summit of the Americas events include many foreign heads of state in attendance including, President Carlos Menem of Argentina, President Gonzalo Sanchez de Lozada of Bolivia, President Itamar Franco of Brazil, President-elect Fernando Henrique Cardoso of Brazil, President Eduardo Frei of Chile, President Jose Maria Figueres of

Costa Rica, President Joaquin Balaguer of the Dominican Republic, President Sixto Duran Ballen of Ecuador, President Armando Calderon Sol of El Salvador, President Ramiro de Leon Carpio of Guatemala, President Cheddi Jagan of Guyana, President Carlos Roberto Reina of Honduras, President Ernesto Zedillo of Mexico, President Violeta Chamorro of Nicaragua, President Ernesto Perez Balladares of Panama, President Juan Carlos Wasmosy of Paraguay, President Alberto Fujimori of Peru, President Ronald Venetiaan of Suriname, President Luis Alberto Lacalle of Uruguay, President Rafael Caldera of Venezuela, Prime Minister Jean Chretien of France, Prime Minister John Compton of Saint Lucia, Prime Minister Nicholas Brathwaite of Grenada, Prime Minister Percival Noel James "P.J." Patterson of Jamaica, Prime Minister Kennedy Simmonds of Saint Kitts and Nevis, Prime Minister James Fitz-Allen Mitchell of Saint Vincent and the Grenadines, and Prime Minister Patrick Manning of Trinidad and Tobago. Select material responsive to this case was previously processed in FOIA case # 2006-1135-F Segments 22 and 62, which contain photographs from March 16, 1993 and July 22, 1993 respectively. This case contains only a small selection of images containing the subject matter, President Aristide. Further items include President William Jefferson Clinton conferring with staff prior to meetings with President Jean-Bertrand Aristide on December 6, 1993, President Clinton and Vice President Al Gore Jr. greeting delegates for the Summit of the Americas during arrival and at dinner on December 9 and 10, 1994, President Clinton and Vice President Gore participating in the Summit of the Americas sessions on December 9 through 11, 1994, and President Clinton participating in various events in Haiti during his visit on March 31, 1995 including greeting US troops stationed in Haiti & touring their facilities and also participating in both arrival & departure ceremonies at the National Palace.

Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
