## **Scope and Content Note**

FOIA 2008-0666-F (Segment 7) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from July 31, 2000 through August 8, 2000, with miscellaneous material filed from June 26, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Photographs from July 31, 2000 are as follows: President William Jefferson Clinton arrives at both Tampa International Airport & West Palm Beach International Airport and greets individuals present at each location. President William Jefferson Clinton greets Representative Jim Davis and others at the Hyatt Regency Hotel. President William Jefferson Clinton stops by the Tampa Bay Buccaneers training camp at the University of Tampa. The President greets members of the team and guests in attendance. President William Jefferson Clinton participates in an interview with Kelly Ring FOX Television. President William Jefferson Clinton addresses a prescription drug event at the David Barksdale Senior Center. Present include President of Barksdale Center Golden Age Club Paul Herrera, among others. President William Jefferson Clinton departs Tampa International

Airport. The President greets members of AmeriCorps prior to departure

Pictured also are Doug Band, Janis Kearney, and Betty Currie in the Outer Oval Office. President William Jefferson Clinton greets Sara Wood-Kraft and her children in the Oval Office. President William Jefferson Clinton participates in a videotaping session in the Cabinet Room at the White House. President William Jefferson Clinton speaks on the telephone with Prime Minister Atal Vajpayee of India. The President confers with Samuel "Sandy" Berger, Bruce Riedel, and John Podesta prior to the phone call. First Lady Hillary Rodham Clinton walks with Huma Abedin along the Colonnade at the White House. Photographs from August 3, 2000 are as follows: President William Jefferson Clinton greets Air Force Doctor Lewis Hoffman at the White House. (August 3, 2000 continued) President William Jefferson Clinton golfs at Army Navy Country Club. Photographs from August 4, 2000 are as follows: President William Jefferson Clinton prepares to deliver his weekly radio address. Following the delivery, the President greets guests in attendance. Present include Mandy Grunwald, Mark Penn, Bruce Reed, Gene Sperling, Joel Johnson, Joe Lockhart, Steve Ricchetti, Loretta Ucelli, John Podesta, Sam Afridi, Karen Tramontano, Doug Band, Lisa Ferdinando, and intern Monique Luse, among others. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton depart the White House via Marine One en route to Andrews Air Force Base. The First Family arrive at Martha's Vineyard Airport. The First Family greets individuals in attendance. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton arrive at Nantucket Airport. The President greets individuals in Nantucket, Massachusetts. Betty Currie and Socks are photographed at the White House. Janis Kearney and Betty Currie are later pictured in the Oval Office. Photographs from August 5, 2000 are as follows: President William Jefferson Clinton vetoes the Marriage Tax Relief Reconciliation Act of 2000 (Marriage Penalty Bill). President William Jefferson Clinton departs Martha's Vineyard via Air Force One en route to Hyannis Port Airport. The President arrives in Hyannis Port. President William Jefferson Clinton arrives at the Kessler Residence for a meeting regarding the Clinton Presidential Library. Present are staffers Joe Lockhart & Terry McAuliffe. Further present are Howard Kessler, Michelle Kessler, David Kessler, Michael Kearney, Sarah

Kearney, Caroline Kearney, Olivia Kearney, and Erika Blankenship. President William Jefferson Clinton plays golf at Farm Neck Golf Club. Present are Tony Fisher, Dirk Ziff, and Vernon Jordan, among others. President William Jefferson Clinton delivers remarks at an event for Kathleen Kennedy Townsend. Photographs from August 7, 2000 are as follows: President William Jefferson Clinton delivers remarks at the U.S. Coast Guard station at West Chop Lighthouse on signing S. 2327 the Oceans Act of 2000. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton depart Martha's Vineyard via Air Force One. Photographs from August 8, 2000 are as follows: President William Jefferson Clinton arrives at Idaho Air National Guard Gowen Field. Present are Governor Dirk Kempthorne, Bruce Babbitt, Representative Helen Chenoweth-Hage, Representative Mike Simpson, Mike Dombeck, Brigadier General Gary Saylor, Lieutenant Colonel Bill Shawver, Victoria Majors, Roberta D'Amico, Rosell Morin, Oliver Payne, and D. Roger Erb, among others. President William Jefferson Clinton tours wildfires in the area around McCall, Idaho. Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
