Summary

This segment consists of photographs created from August 26, 2000 through August 28, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.

Scope and Content Note

FOIA 2008-0666-F (Segment 12) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from August 26, 2000 through August 28, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Of particular note is a trip to Nigeria by President Clinton and Chelsea Clinton, and President Clinton attending the Burundi Peace Accord. Photographs from August 26, 2000 are as follows: President William Jefferson Clinton addresses a reception at the Hilton Hotel. President William Jefferson Clinton addresses the Nigerian Joint Assembly at the National Assembly Building in Abuja, Nigeria. Present are Chelsea Clinton, Ibrahim Mantu, Deputy Senate President, and Chibudum Nwuche, Deputy Speaker of the House. Photographs from August 27, 2000 are as follows: President William Jefferson Clinton and Chelsea Clinton attend church services at the First Baptist Church in Abuja, Nigeria. Present are also President Olusegun Obasanjo and Mrs. Stella Obasanjo. President William Jefferson Clinton and Chelsea Clinton visit Ushafa Village in Ushafa, Nigeria. Chief Alhaji Mohammadu Baba gives a tour of the

village. A performance is put on in the market square of the village. The President greets performers and people in the crowd. President William Jefferson Clinton addresses the American community of the United States Embassy at the Nicon Hilton Hotel in Abuja, Nigeria. Present are Chelsea Clinton, Nancy Morgan Sherpa, Representatives Spencer Bachus, Charles Rangel, Donald Payne, and Sheila Jackson Lee. President William Jefferson Clinton and Chelsea Clinton tour exhibits at the National Center for Women Development. The President delivers remarks to health care providers regarding AIDS. President William Jefferson Clinton addresses the Nigerian business community at the Ladi Kwali Conference Center in Abuja, Nigeria. President William Jefferson Clinton and Chelsea Clinton go shopping in Abuja, Nigeria. President William Jefferson Clinton and Chelsea Clinton attend dinner at the Sheraton Hotel in Abuja, Nigeria. Present are Rodney Slater, John Podesta, Sandy Berger, Bruce Lindsey, and Reverend Jesse Jackson, among others. Photographs from August 28, 2000 are as follows: President William Jefferson Clinton participates in a departure ceremony with President Olusegun Obasanjo at Nnamdi Azikiwe International Airport in Abuja, Nigeria. The President, Chelsea Clinton, and the United States delegation depart via Air Force One en route to Arusha, Tanzania. Air Force One arrives at Kilimanjaro International Airport. The President greets President Benjamin William Mkapa, Foreign Minister Jakaya Kikwete, and Ambassador Charles Stith, among others. President Clinton and President Mkapa participate in an event for the Open Skies Agreement signing. President William Jefferson Clinton meets with former President Nelson Mandela of South Africa at the Arusha International Conference Center in Arusha, Tanzania. President Mandela greets Chelsea Clinton and also members of the United States delegation. President William Jefferson Clinton along with current and former Heads of State attend the Burundi Peace Accords in Arusha, Tanzania. Present are former President Nelson Mandela of South Africa, (August 28, 2000 cont.) President Daniel A. Moi of Kenya, President Yoweri Museveni of Uganda, President Benjamin Mkapa of Tanzania, President Pasteur Bizimungu of Rwanda, President Pierre Buyoya of Burundi, President Bakili Muluzi of Malawi, President Gnassingbe Eyadema of Togo, President Jerry Rawlings of Ghana, President Meles Zenawi of Ethiopia, President Joaquim Chissano of Mozambique, and Prime Minister Hage Geingob of Namibia. President William Jefferson Clinton and Chelsea Clinton tour exhibits at the Cultural Heritage Center in Arusha, Tanzania. President William Jefferson Clinton and the United States delegation depart Tanzania via Air Force One en route to Egypt.

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
