

## **Extent**

Approximately 2,256 photographs in color and black & white film processed from 35mm negatives.

## **Summary**

This segment consists of photographs created from August 18, 2000 & August 22, 2000 through August 26, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.

## **Scope and Content Note**

FOIA 2008-0666-F (Segment 11) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from August 18 2000, and August 22 through 26, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Of particular note is a trip to Nigeria by President Clinton and Chelsea Clinton. Photographs from August 18, 2000 are as follows: President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton arrive at the Adirondack Airport in Saranac Lake, New York. President William Jefferson Clinton and First Lady Hillary Rodham Clinton address the Franklin, Essex and Clinton County Democratic Picnic at the Saranac Lake Civic Center. Chelsea Clinton is also present. (Note: some of these images are marked as being from August 19, 2000 but that date appears to be listed incorrectly). Photographs from August 22, 2000 are as follows: President William Jefferson Clinton meets in the Oval Office with welfare to work corporate executive officers. Present are Eli Segal, Bruce Reed, and Karen Tramontano, among others. President William Jefferson Clinton departs the White

House via Marine One en route Andrews Air Force Base. The President arrives at Selfridge Air National Guard Base. President William Jefferson Clinton addresses a reception for Representative Debbie Stabenow in Bloomfield Hills, Michigan. President William Jefferson Clinton departs Selfridge Air National Guard Base en route Andrews Air Force Base. Photographs from August 23, 2000 are as follows: President William Jefferson Clinton delivers a statement in the Rose Garden regarding the California Electricity Shortage. Present are Bill Richardson and Donna Shalala. Prior to the statement President Clinton and staff meet in the Oval Office for a briefing. Present include Jake Siewert, John Podesta, Karen Tramontano, Joel Johnson, Sylvia Mathews, Loretta Ucelli, Samuel "Sandy" Berger, and Doug Band. President William Jefferson Clinton departs from Andrews Air Force Base en route to New Jersey. The President arrives at the ETS Landing Zone. The President participates in events for Representative Rush Holt and Congressional Candidate Susan Bass Levin. Later the President proceeds to the School Construction Event at Crossroads Middle School in Monmouth Junction, New Jersey. The President delivers remarks at the school. President William Jefferson Clinton arrives at Trenton Mercer County Airport. The President proceeds to Princeton and stops at a Starbucks with Representative Rush Holt. The President participates in an interview with Esquire Magazine with Mike Paterniti. President William Jefferson Clinton arrives at Andrews Air Force Base. Photographs from August 24, 2000 are as follows: President William Jefferson Clinton participates in a briefing in the Oval Office with Madeleine Albright, Sandy Berger, John Podesta, and Lael Brainard. President William Jefferson Clinton meets with Secretary Bill Daley, John Podesta, and Steve Ricchetti in the Oval Office. President William Jefferson Clinton greets departing military personnel in the Oval Office. President William Jefferson Clinton prepares to deliver televised remarks to the Columbian people. President William Jefferson Clinton meets with President-Elect Vicente Fox of Mexico at the White House. Present are Maria Echaveste, Barry McCaffrey, Lael Brainard, and Mickey Ibarra, among others. Photographs from August 25, 2000 are as follows: President William Jefferson Clinton tapes his weekly radio address in the Oval Office. President William Jefferson Clinton and Chelsea Clinton greet The Dixie Chicks - Natalie Maines, Martie Seidel, and Emily Robinson - in the Oval Office. President William Jefferson Clinton and Chelsea Clinton prepare to leave the White House for Nigeria. They depart for Andrews Air Force Base via Marine One. Upon arrival they embark upon Air Force One en route to Nigeria. Photographs from August 26, 2000 are as follows: President William Jefferson Clinton and Chelsea Clinton disembark Air Force One at Nnamdi Azikiwe International Airport

in Abuja, Nigeria. They are greeted by President Olusegun Obasanjo. President Clinton and President Obasanjo participate in an arrival ceremony at the airport. Present among the United States' delegation are John Podesta, Rodney Slater, Bill Richardson, Reverend Jesse Jackson, Charles Rangel, Jim McDermontt, Donald Payne, William Jefferson, Eddie Bernice Johnson, Spencer Bachus, Chaka Fattah, Sheila Jackson Lee, Julia Carson, Carolyn Kilpatrick, Gregory Meeks, and Stephanie Tubbs Jones, among others. President William Jefferson Clinton is briefed prior to a press conference with President Olusegun Obasanjo. Present are Samuel "Sandy" Berger, Bruce Lindsey, Gayle Smith, Jake Siewert, and John Podesta, among others. President William Jefferson Clinton participates in two bilateral meetings with President Olusegun Obasanjo at the presidential villa in Abuja, Nigeria. President Clinton and President Obasanjo later sign a joint declaration and deliver a joint press statement. President William Jefferson Clinton delivers an address at the National Assembly Building in Abuja, Nigeria. (August 26, 2000 continued) President William Jefferson Clinton and Chelsea Clinton arrive at the International Conference Center in Abuja, Nigeria to attend the state dinner hosted by President Olusegun Obasanjo. President Clinton and President Obasanjo deliver remarks and a toast. The attendees watch a performance. Attendees dance following the performance. Following the event President Clinton and Chelsea Clinton return to the Nicon Hilton Hotel.

## **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
