Summary

The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, White House Staff and others for the time period processed

Scope and Content Note

FOIA 2008-0666-F (Segment 15) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from September 1, 2000, and September 8, 2000 through September 14, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. A notable amount of material responsive to this selection was processed in FOIA case # 2014-0594-F, which includes material from September 8, 2000. Photographs from September 1, 2000 are as follows: President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet individuals present at the Southwest Community Center in Syracuse, New York. Photographs from September 8, 2000 are as follows: President William Jefferson Clinton participates in separate bi-lateral meetings with President Jiang Zemin of China, President Hugo Banzer Suarez of Bolivia, and Prime Minister Bertie Ahern of Ireland at the Waldorf-Astoria Hotel in New York, NY. President William Jefferson Clinton meets with Prime Minister Ehud Barak of Israel at the Park Lane Hotel in New York, NY. Present are Madeleine Albright, Samuel "Sandy" Berger, Danny Yatom, and

Rob Malley, Among others. President William Jefferson Clinton greets people at the Stage Deli in New York, NY. Present are Madeleine Albright, Sandy Berger, Terry McAuliffe, and Dorothy McAuliffe, among others. Photographs from September 9, 2000 are as follows: President William Jefferson Clinton participates in a bi-lateral meeting with Gustavo Noboa Bejarano of Ecuador at the Waldorf-Astoria Hotel. Photographs from September 10, 2000 are as follows: President William Jefferson Clinton shops at Lange's Little Store and Delicatessen in Chappaqua, New York. President William Jefferson Clinton departs Westchester County Airport en route Andrews Air Force Base. The President arrives at the South Portico at the White House. Photographs from September 11, 2000 are as follows: President William Jefferson Clinton and First Lady Hillary Rodham Clinton depart the White House via Marine One en route Andrews Air Force Base. The President and First Lady disembark Air Force One at Westchester County Airport. President William Jefferson Clinton and First Lady Hillary Rodham Clinton arrive at the Jewish Community Center. The President delivers remarks. Present are Representative Nita Lowey, Patty Cathers, Peggy Charren, and Andrew Spano, among others. Following the event the President and First Lady depart en route Scarsdale High School. The President and First Lady greet individuals at the school. The President and First Lady depart Scarsdale High School Landing Zone via Marine One en route Danbury, Connecticut. (September 11, 2000 continued) President William Jefferson Clinton and Representative Jim Maloney participate in a luncheon at Connecticut University. Later the President and Representative Maloney address the Danbury Community at the Western Connecticut University Charles Ives Center for Performing Arts. President William Jefferson Clinton disembarks Marine One at the Wall Street Landing Zone in New York, NY. President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet individuals at The Waterford. The President and First Lady proceed to the Bronfman Gala and the Pierre Hotel. Photographs from September 12, 2000 are as follows: President William Jefferson Clinton departs Westchester County Airport en route Andrews Air Force Base. The President greets Chelsea Clinton prior to her departure from Andrews Air Force Base. The President proceeds to golf at Andrews Air Force Base. Present are Steve Ricchetti and Joe Lockhart. The President later proceeds to the White House via Marine One. Upon arriving the President delivers a statement. President William Jefferson Clinton participates in an interview with Karen Breslau and Katrina Heron of Wired Magazine. Present are Jake Siewert and Tom Kalil. The President later greets Non-Executive Office of the President (NON-EOP) staff in the Oval Office at the White

House. President William Jefferson Clinton participates in a briefing in the Oval Office for a bi-partisan Congressional meeting to take place in the Cabinet Room. Present are Larry Summers, Charles ("Chuck") Brain, Gene Sperling, Jack Lew, John Podesta, Sandy Berger, Joe Lockhart, Sylvia Mathews, Charles Burson, Karen Tramontano, Loretta Ucelli, Joel Johnson, Maria Echaveste, Chris Jennings, Steve Ricchetti, and Barbara Chow. The President proceeds to the meeting in the Cabinet Room. Present are House Speaker Dennis Hastert, Representatives Dick Armey, David Bonior, and Richard Gephardt, Senators Trent Lott, Harry Reid, Tom Daschle, and Don Nickles, among others. Photographs from September 13, 2000 are as follows: President William Jefferson Clinton meets with Northern Ireland First Minister David Trimble and Deputy First Minister Seamus Mallon. President William Jefferson Clinton participates in a briefing for the Hate Crimes Event to be held in the East Room. The President proceeds to the East Room to deliver remarks on the legislative agenda on hate crimes. Present are Eric Holder, David O'Malley, and Sherialynn Byrdsong, among others. First Lady Hillary Rodham Clinton participates in a Senatorial candidate debate at Buffalo Public Television Station in New York with Representative Rick Lazio. Photographs from September 14, 2000 are as follows: President William Jefferson Clinton delivers remarks at the annual White House Prayer Breakfast in the State Dining Room.

Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
