**Summary**

This collection consists of photographs of Clinton Administration staff on November 17, 1995. Of particular focus is Jennifer Palmieri, whom served as Deputy Director of Scheduling & Advance at the White House. Many records responsive to this request were processed under FOIA request 2014-0664-F. Only a small selection of responsive photographs contain Jennifer Palmieri.

**Scope and Content Note**

The materials in FOIA 2018-1211-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. FOIA request 2018-1211-F contains photographs of Clinton Administration staff on November 17, 1995. Of particular focus is Jennifer Palmieri, whom served as Deputy Director of Scheduling & Advance at the White House. Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton

Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
