

## **Extent**

Approximately 2,225 photographs in color and black & white film processed from 35mm negatives and born digital images.

## **Summary**

The photographs processed in this segment were created from October 23, 2000 & October 25 through October 30, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff and others for the time period processed.

## **Scope and Content Note**

FOIA 2008-0666-F (Segment 24) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from October 23, 2000 & October 25, 2000 through October 30, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, White House Staff and others for the time period processed. Note: Numerous photos from this segment were previously processed in prior FOIA request 2018- 0078-F & 2016-0595-F (See Inventory of Photograph Contact Sheets). ## **System of Arrangement**

Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
