

## **Extent**

Approximately 2,379 photographs in color and black & white film processed from 35mm negatives and born digital images.

## **Summary**

The photographs processed in this segment were created from October 22, 2000 through October 25, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff and others for the time period processed.

## **Scope and Content Note**

FOIA 2008-0666-F (Segment 23) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from October 22, 2000 through October 25, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, White House Staff and others for the time period processed. Note: Numerous photos from this segment were previously processed in prior FOIA request 2016- 0871-F & 2018-0078-F (See Inventory of Photograph Contact Sheets). Photographs from October 22, 2000 are as follows: President Clinton arrives at Andrews Air Force Base for a departure to Binghamton, New York President Clinton talks on the telephone and works on a crossword puzzle during his flight to New York on Air Force One President Clinton arrives at Binghamton Regional Airport and is met by Representative Maurice Hinchey and others President Clinton addresses a Hillary Rodham Clinton for Senate event at the Fountains Pavilion in Johnson City, New York President Clinton departs Binghamton Regional Airport for a flight to Watertown, New York President Clinton addresses a reception for Hillary Rodham Clinton at the Bonnie Castle Resort in New York President Clinton and

Elton John performs at the event and the Clintons talk to Mary Steenburgen and Ted Danson.

A red school house is constructed on the South Lawn. President Clinton greets guests in the State Dining Room following the South Lawn event. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
