## **Summary**

This collection consists of Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from November 5, 2000 through November 9, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff and others for the time period processed

## **Scope and Content Note**

FOIA 2008-0666-F (Segment 27) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from November 5, 2000 through November 9, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, White House Staff and others for the time period processed. Photographs from November 5, 2000 are as follows: President Clinton participates in a Pine Bluff Community event at the Pine Bluff Convention Center in Pine Bluff, Arkansas. Secretary Rodney Slater and others deliver remarks to the Pine Bluff Community Photographs from November 6, 2000 are as follows: President Clinton makes telephone calls and participates in election interviews in the Map Room. President Clinton is assisted by Minyon Moore, Joel Johnson, Megan Moloney and others are present in the Map Room Photographs from November 7, 2000 are as follows: President Clinton, Hillary Rodham Clinton and Chelsea Clinton participating in the voting process at their polling station at Douglas Graffin Elementary School in Chappaqua, New York. Hillary Rodham Clinton votes in the voting booth in the

school's cafeteria. The Clintons pose with women wearing Hillary Rodham Clinton masks and holding signs outside the polling station. President Clinton and Hillary Rodham Clinton visit and greet Lange's Little Store and Deli in Chappaqua and greet workers and the customers Chelsea Clinton with her father President Clinton at his Chappaqua residence desk working on election strategy and reviewing polls. President Clinton, Hillary Rodham Clinton and Chelsea Clinton spend election night with family and friends at the Grand Hyatt Hotel in New York City. President Clinton and others watch election television coverage in his suite at the Grand Hyatt Hotel. Hillary Rodham Clinton delivers her acceptance speech for U.S. Senate from New York in the Empire State Ballroom at the Grand Hyatt Hotel and is joined on the dais by President Clinton, Chelsea Clinton, Senator Daniel Patrick Moynihan and Senator Charles Schumer. Photographs from November 8, 2000 are as follows: President Clinton and Chelsea Clinton arrive via Marine One at Westchester County Airport in White Plains, New York. Hillary Rodham Clinton gives a press conference following her U.S. Senate Election victory and greets a large crowd at Grand Central Station in New York City. Hillary Rodham Clinton reads a newspaper on her flight from New York to Andrews Air Force Base in Maryland. Hillary Rodham Clinton greets Air Force personnel on her arrival to Andrews and later arrives at the South Portico entrance of the White House. President Clinton and Chelsea Clinton disembark Marine One on the South Lawn at the White House and President Clinton delivers a statement to the press on the South Lawn. Photographs from November 9, 2000 are as follows: President Clinton participates in a bilateral meeting in the Oval Office with Chairman Arafat of the Palestinian Authority. Meeting participants include: Secretary of State Madeleine Albright, Sandy Berger, Dennis Ross and others. Hillary Rodham Clinton talks with the press pool reporters about the 2000 Millennium China by Lenox in the East Room. White House Pastry Chef Roland Mesnier holds up desserts during the Press Preview in the East Room. President Clinton and Hillary Rodham Clinton host the White House Historical Association 200th Anniversary Dinner in the East Room. The Clintons visit with Former President's Gerald Ford, Jimmy Carter, George Bush and Former First Ladies Lady Bird Johnson, Betty Ford, Rosalynn Carter, Barbara Bush and guests in the Yellow Oval Room, Center Hall and East Room throughout the dinner. Chelsea Clinton is also present at the dinner.

## **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
