**Summary**

This collection consists of unclassified electronic records regarding Anthony Lake and events during the Kosovo conflict. Anthony Lake served as National Security Advisor from 1993 to 1997. It contains NSC cables and email. Subjects include various aspects of a Samuel Berger memo on White House communication strategies dealing with the end of the war in Kosovo.

**Scope and Content Note**

The materials in FOIA 2019-0351-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. Anthony Lake served as National Security Advisor under President Bill Clinton from 1993 to 1997. The Clinton Presidential records to be opened consist of NSC emails. The emails coordinate various aspects of a Samuel Berger memo on White House communication strategies dealing with the end of the war in Kosovo.
