**Summary**

This collection consists of records from 1992 to 1995 related to meetings between US government representatives and delegations from South Africa during which the dismantling of its Space Launch Vehicle (SLV) program was discussed. It contains National Security Council cables and emails that include press material and administration accomplishment reports.

**Scope and Content Note**

The materials in FOIA 2019-0398-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. The requester asked for material from 1992 to 1995 related to meetings between US government representatives and delegations from South Africa during which the dismantling of its Space Launch Vehicle (SLV) program was discussed. Records responsive to this request include NSC cables and NSC email. Subjects include press material and administration accomplishments. The majority of records related to this FOIA case are closed for national security reasons.
