Summary

This segment of the collection consists of photographs taken from December 21, 2000 through December 31, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Of particular focus is holiday festivities in Washington, DC and various holiday staff parties at the White House.

Scope and Content Note

FOIA 2008-0666-F (Segment 42) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000. The photographs processed in this segment were created from December 21, 2000 through December 31, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Of particular focus is holiday festivities in Washington, DC, including parties and similar staff events at the White House. Photographs from December 21, 2000 are as follows: President William Jefferson Clinton meets with Vice President Al Gore in the Oval Office. President William Jefferson Clinton signs the Labor, Health and Human Services bill in Presidential Hall of the Eisenhower Executive Office Building. Present include Aida Alvarez, Richard Riley, Alexis Herman, Sylvia Mathews, Maria Echaveste, Donna Shalala, Jack Lew, and Gene Sperling. Photographs from December 22, 2000 are as follows: President William Jefferson Clinton tapes his weekly radio address. The President greets guests in attendance including Steve Ricchetti, William Cohen, Andrew Cuomo, Ethel Kennedy, Kenneth

Lieberthal, Melanne Verveer, Kris Balderston, and John Podesta, among others. President William Jefferson Clinton and First Lady Hillary Rodham Clinton meets with the Grand Rabbi of New Square in the Oval Office. President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton greet staff and their families at a holiday Christmas party at the White House. Bettie Currie is photographed in various locations in the Oval Office and West Wing. Photographs from December 23, 2000 are as follows: President William Jefferson Clinton meets with Israeli and Palestinian negotiators in the Cabinet Room. Present include Gilad Sher of Israel, Palestinians Saeb Erekat and Mohamad Dahlan, Madeleine Albright, Dennis Ross, Steve Ricchetti, Aaron Miller, John Podesta, Sandy Berger, and Rob Malley. Photographs from December 24, 2000 are as follows: President William Jefferson Clinton and First Lady Hillary Rodham Clinton walk to the Presidential limousine after attending service at the Foundry United Methodist Church. President William Jefferson Clinton speaks on the telephone in a call to deliver Christmas greetings to members of the United States military. Present include military aide Major William Mullen and the White House Television office crew. Photographs from December 27, 2000 are as follows: President William Jefferson Clinton delivers remarks on the appointment of Roger Gregory to the United States Court of Appeals for the Fourth Circuit. Judge Gregory and his family are present. President William Jefferson Clinton signs HR 5630; the Intelligence Authorization Act for Fiscal Year 2001. Senator Daniel Patrick Moynihan is present. President William Jefferson Clinton greets Governor Gray Davis and Mrs. Davis in the Oval Office. The two proceed to the Outer Oval Office after the meeting. The President later meets William Daley in the Outer Oval Office. Master Chef Tony Powell has lunch with guests in the White House Mess, including Felton Spencer of the New York Knicks. Photographs from December 28, 2000 are as follows: President William Jefferson Clinton delivers remarks announcing the Global Food for Education initiative. George McGovern and Senator Robert Dole also deliver remarks. Present include Senators Byron Dorgan and Patrick Leahy, Representatives Tom Hall and James McGovern, Catherine Bertini, Jacques Diof, and Sven Sandtrom. President William Jefferson Clinton is briefed by Larry Summers, Sylvia Mathews, Martin Baley, Stuart Eizenstat, Jake Siewert, Mara Rudman, Loretta Ucelli, Jeff Shesol, Jack Lew, Chuck Brain, and John Podesta in the Oval Office prior to a statement on debt relief. The President delivers remarks in the Press Briefing Room on debt relief. President William Jefferson Clinton greets individuals in the Oval Office. The President greets Margaretta "Happy" Rockefeller and family. Terry McAuliffe is present. The President greets Mark Penn.

Present include Tom Freedman, Chuck Brain, and John Podesta. The President also greets Roger Clinton. President William Jefferson Clinton participates in a telephone call with Chancellor Gerhard Schroeder of Germany. President is Mara Rudman, among others. Photographs from December 29, 2000 are as follows: President William Jefferson Clinton tapes his weekly radio address. Present are Loretta Ucelli, Paul Glastris, Lisa Ferdinando, and Ronald Minsk are present. Photographs from December 30, 2000 are as follows: President William Jefferson Clinton meets with members of the Clinton family in the Oval Office prior to departing for Camp David. The President, First Lady Hillary Rodham Clinton, and Clinton family embark Marine One en route Camp David. Photographs from December 31, 2000 are as follows: President William Jefferson Clinton and First Lady Hillary Rodham Clinton shop in Frederick, Maryland.
