Summary

The video recording from the White House Television Office (WHTV) Master Tape# 01719 contains President Clinton delivering brief remarks in the Oval Office regarding his Executive Order signing for Environmental Justice in Minority Communities in the United States. Additional video events on this tape include: President Clinton greeting departing U.S. military personnel and a U.S. Secret Service agent and family in the Oval Office and President Clinton hosting a breakfast at the White House for Prime Minister and Mrs. Morihiro Hosokawa.

Scope and Content Note

The material in FOIA 2019-0993-F is a selective video responsive to the topic of the FOIA. Researchers should consult the archivist about related material. FOIA request 2019-0993-F includes one selected master tape video recording from the White House Television Office (WHTV). The video recording contains approximately thirteen minutes in total of the President delivering brief remarks regarding his Executive Order signing for Environmental Justice in Minority Communities in the United States. Vice President Gore also makes remarks at the signing in the Oval Office on February 11, 1994. The signing ceremony included: Attorney General Janet Reno, EPA Administrator Carol Browner, Katie McGinty, Senator Paul Wellstone, Representative John Lewis, Representative John Conyers and others. The subject of the President's remarks and executive order focused on protecting minority communities and low income populations from pollution. Additional video events on the responsive White House Television video tape include: February 10, 1994, President Clinton greeting a departing U.S. Secret Service agent and his family in the Oval Office (approximately thirty seconds in duration) February 10, 1994. President Clinton greeting departing U.S. Military personnel in the Oval Office (approximately

six minutes in duration) February 12, 1994, President Clinton hosting a breakfast in the Residence Family Dining Room for Prime Minister and Mrs. Morihiro Hosokawa (approximately four minutes in duration).
