

## **Extent**

500 photographs in color film processed from 35mm and 2 video recordings in BetacamSP format totaling approximately 45 minutes total run time.

## **Summary**

Contains photographs and video recordings of President William Jefferson Clinton with Reverend Al Sharpton. One event was processed as being responsive to this case as described by the White House Photograph Office from December 22nd, 1998, and is of a Christmas reception at the White House.

## **Scope and Content Note**

The materials in FOIA 2020-0036-F are a selective body of audiovisual materials responsive to the topic of the FOIA. Researchers should consult the archivist about related material. FOIA request 2020-0036-F contains photographs and video recordings of President William Jefferson Clinton with Reverend Al Sharpton. One event was processed as being responsive to this case as described by the White House Photograph Office from December 22nd, 1998, and is of a Christmas reception at the White House. Also photographed at the event include Ralph Alswang, Linda Kulman, Marilyn Jacanin, David Dinkins, Ray Kelley, Mickey Ibarra, Susie Tompkins Buell, Mark Buell, Megan Moloney, Brenda Anders, Carmen Fowler, Lanny Davis, Ben Johnson, Mayor Marion Barry, and David O'Connor, among others. Note: Only a small amount of material processed in this case is responsive to the subject matter.

## **System of Arrangement**

Records that were responsive to this FOIA request were found in two collections and two series, Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein - Photographs Relating to the Clinton Administration, and Clinton Presidential Records: Video Recordings of the White House Television Office and the series therein - Video Recordings Relating to the Clinton Administration. Processing was done at the folder/contact sheet level for photographs and at the individual item level for video. While this method maintains folder/contact sheet integrity for photographs and tape run time integrity for video, it frequently results in the incidental processing of photographs and video recordings that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
