Summary

Scope and Content Note

FOIA 2016-0100-F (Segment 10) is a request for all Clinton Administration White House photographs taken from December 1, 1999 through January 31, 2000. The photographs processed in this segment were created from December 16 & 18, 1999 & January 2, 2000 & January 4, 2000 through January 5, 2000 & January 7, 2000 through January 10, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff and others for the time period processed. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
