Summary

Contains photographs of President Clinton and Hillary Rodham Clinton hosting a Baseball Reception and Picnic at the White House on September 10, 1994. Photographs include the Clintons greeting guests in the Diplomatic Reception Room and on the South Lawn. Notable guests include former Major League Baseball players Curt Flood, Tim McCarver and their families, former Negro League Baseball player Buck O'Neil and other former Negro League players, Ken Burns and others.

Scope and Content Note

The materials in FOIA 2020-0315-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. FOIA request 2020-0315-F contains photographs of President William Jefferson Clinton and Hillary Rodham Clinton hosting a baseball reception and picnic at the White House on September 10, 1994. Hillary Rodham Clinton takes batting practice in a batting cage set-up on the South Lawn. The Clintons greet guests in the Diplomatic Reception Room and on the South Lawn. Notable guests include former Major League Baseball players Curt Flood, Tim McCarver and their families. The Clintons greet former Negro League Baseball player Buck O'Neil and other former Negro League players, Ken Burns and others at the reception. The picnic included late 1880's period dressed baseball players and others in period dressed costumes.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
