## **Summary**

## **Scope and Content Note**

Margy Waller served as Associate Director for Domestic Policy for the Domestic Policy Council from 2000-2001 where she served as Senior Advisor for Welfare and Working Families. Waller's primary job was to provide advice, edits, and liaison between agencies, the White House, and congressional staff members for federal rules and regulations that related to welfare reform. This collection highlights Waller's work on Clinton administration initiatives that involved family issues including fatherhood, TANF (Temporary Assistance for Needy Families), child support, and HUD (Department of Housing and Urban Development) affordable housing proposals. Other topics highlighted in this collection are homelessness, welfare-to-work initiatives, charitable choice, SNAP (Supplemental Nutrition

Assistance Program) benefits, food stamp benefits, and family issues.
