Summary

The photographs processed in this case relating to President Clinton and First Lady Hillary Rodham Clinton participating in Ford's Theatre events on February 8, 1998. These events are a reception at the White House and a program at Ford's Theatre in Washington, DC.

Scope and Content Note

The materials in FOIA 2021-0412-F are a selective, not necessarily all inclusive, body of photographs responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. The content consists of photographs and video recordings related to David Copperfield participating in Ford's Theatre events on February 8, 1998. Photographs include: President Clinton and First Lady Hillary Rodham Clinton hosting a reception in the Blue Room at the White House for Ford's Theatre; President Clinton and the First Lady greeting reception guests including: David Copperfield, John Fogerty, Whoopi Goldberg, Lynda Robb and others; President Clinton and First Lady Hillary Rodham Clinton attending the annual Ford's Theatre Gala at Ford's Theatre in Washington, DC; President Clinton delivering remarks and the First Lady assisting Magician David Copperfield with his performance at the Gala; The First Lady receiving a medal and delivering remarks at the Ford's Theatre Gala. The White House Television (WHTV) video recordings contain video footage of Whoopi Goldberg introducing President Clinton, President Clinton delivering remarks and the First Lady receiving a medal and delivering remarks at the Ford's Theatre Gala; President Clinton and First Lady Hillary Rodham Clinton participating in a receiving line greeting Ford's Theatre reception guests in the Blue Room, Guests include: David Copperfield, John Fogerty, Whoopi Goldberg and others. Other events that were included on WHTV video recordings include:

President Clinton, First Lady Hillary Rodham Clinton and Buddy the dog arriving on the South Lawn at the White House on Marine One on February 8, 1998; President Clinton arriving on the South Lawn at the White House on February 10, 1998; President Clinton participating in a photo opportunity with President Petar Stoyanov of Bulgaria in the Oval Office on February 10, 1998; President Clinton arriving to the Cabinet Room for a meeting with President Petar Stoyanov of Bulgaria on February 10, 1998; President Clinton greeting and participating in a group photo with the staff of the Council of Economic Advisors (CEA) in the Oval Office on February 10, 1998; Janet Yellen and CEA staff presenting President Clinton with publication in the Oval Office on February 10, 1998.

System of Arrangement

Records that were responsive to this FOIA request were found in two collections and two series, Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein - Photographs Relating to the Clinton Administration, and Clinton Presidential Records: Video Recordings of the White House Television Office and the series therein - Video Recordings Relating to the Clinton Administration. Processing was done at the folder/contact sheet level for photographs and at the individual item level for video. While this method maintains folder/contact sheet integrity for photographs and tape run time integrity for video, it frequently results in the incidental processing of photographs and video recordings that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore

records may be restricted in whole or in part in accordance with legal exemptions.
