The collection includes records related to Vice Admiral Thomas Wilson and the crises in the former Yugoslavia. It consists of cables regarding international response to the conflict in Kosovo, especially on the part of the European Union and the United Nations.

**Scope and Content Note**

The materials in FOIA 2019-0881-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This FOIA case contains materials regarding Thomas Wilson and the crisis in the former Yugoslavia between 1996 and 2001. Vice Admiral Wilson served as the 13th Director of the Defense Intelligence Agency from 1999 to 2002. This FOIA case includes cables regarding international response to the conflict in Kosovo, especially on the part of the European Union and the United Nations. The majority of the records related to this FOIA case are closed for national security reasons.
