**Summary**

The collection includes records related to Lieutenant General Patrick M. Hughes and the crises in the former Yugoslavia. It consists of cables date from 1997 to 2001 that mention, reference, or were copied to Lieutenant General Hughes. These communications primarily address United States and European involvement in matters concerning the nations of the former Yugoslavia.

**Scope and Content Note**

The materials in FOIA 2019-0882-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This case contains records related to Patrick M. Hughes and the former Yugoslavia. Lieutenant General Hughes served as the 12th Director of the Defense Intelligence Agency from 1996 to 1999. The collection consists of cables dating from 1997 to 2001 that mention, reference, or were copied to Lieutenant General Hughes. These communications primarily address United States and European involvement in matters concerning the nations of the former Yugoslavia, particularly related to trade and the economy.
