Summary

Material includes President Clinton greeting guests in the Oval Office and meeting with staff at the White House.

Scope and Content Note

FOIA 2022-0237-F is a request for photographs taken on August 19, 1994, at celebrations at the White House for President William Jefferson Clinton and Second Lady Mary Elizabeth "Tipper" Gore. Material includes the President greeting guests in the Oval Office and meeting with staff at the White House. Photographed include President Clinton, First Lady Hillary Rodham Clinton, Vice President Al Gore, Jr., Tipper Gore, David Crosby, Stephen Stills, Graham Nash, David Geffen, Carolyn Huber, Attorney General Janet Reno, Secretary of Defense William Perry, and George Stephanopoulos, among others. Material processed as consequence includes a meeting on August 23, 1994, in the Cabinet Room of the White House. Additional photographs were processed in FOIA case numbers 2016-0871-F.

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
