Summary

The photographs processed in this segment were created on January 28, 1995. The White House photographer assigned to follow the President on this day was Bob McNeely. The case contains photographs pertaining to meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, White House Staff, and others for the date processed.

Scope and Content Note

FOIA 2022-0202-F is a request for all photographs taken on January 28, 1995, by White House photographers. The photographer assigned to follow the President on this day was Bob McNeely. Photographers would turn in their daily rolls to the White House Photograph Office for processing and roll number assignment, meaning while images are roughly in chronological order to how they were taken some minor discrepancies will be present depending on what order the material was turned in. FOIA processing for this case will maintain the integrity of the roll numbers assigned. Individuals photographed include President William Jefferson Clinton, Vice President Al Gore, Jr., Leon Panetta, Alice Rivlin, Bowman Cutter, Rahm Emanuel, Secretary Donna Shalala, Representative Richard Gephardt, Representative Jan Meyers, Representative Sam Gibbons, Representative William Clay, Senator Bob Packwood, Senator Ted Kennedy, Senator Daniel Patrick Moynihan, Senator John Breaux, Senator Barbara Mikulski, Governor Tom Carper, Governor Mel Carnahan, and Governor Tommy Thompson, among others. Key events responsive to this case include a meeting on welfare and a press statement at the White House.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
