Approximately 811 photographs in color and black & white film processed from 35mm negatives.

Summary

The photographs processed in this segment were created on September 26, 1994. The White House photographers assigned to follow the President on this day include Sharon Farmer, Bob McNeely, and Barbara Kinney. The case contains photographs pertaining to meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff, and others for the date processed.

Scope and Content Note

FOIA 2022-0200-F is a request for all photographs taken on September 26, 1994, by White House photographers. The photographers assigned to follow the President on this day include Sharon Farmer, Bob McNeely, and Barbara Kinney. Photographers would turn in their daily rolls to the White House Photograph Office for processing and roll number assignment, meaning while images are roughly in chronological order to how they were taken some minor discrepancies will be present depending on what order the material was turned in. FOIA processing for this case will maintain the integrity of the roll numbers assigned. Photographs processed for September 26, 1994, are as follows: Key events responsive to this case include Hillary Rodham Clinton greeting Dave McCarthy in the West Wing, greeting Tomi Youngblood in the West Wing, President Clinton addressing the United Nations General Assembly in New York, attending a United Nations luncheon at the United Nations building in New York, greeting police officers at the Waldorf-Astoria Hotel in New York, attending a reception at the Metropolitan Museum of Art for all heads of state and their delegations in New York, participating in a bilateral meeting with President Carlos Salinas of Mexico at the Waldorf-Astoria Hotel, meeting with President Franjo

Tudjman of Croatia at the United Nations Department of Peacekeeping in New York, meeting with Ambassador Madeleine Albright, Secretary Warren Christopher, Tony Lake, Neal Wolin, Mack McLarty, David Gergen, Don Steinberg, Bruce Lindsey, and others at the Waldorf-Astoria, visiting the United Nations Department of Peacekeeping Situation Room with Ambassador Madeleine Albright, Under Secretary General Kofi Annan, Secretary Warren Christopher, and Tony Lake, departing New York and meeting with Dee Dee Myers, Tony Lake, and others in the conference room aboard Air Force One, and views of Marine One on the South Lawn after arriving from New York. Individuals photographed include President William Jefferson Clinton, First Lady Hillary Rodham Clinton, Secretary Warren Christopher, Dave McCarthy, Tomi Youngblood, Tony Lake, Ambassador Madeleine Albright, Bruce Lindsey, Dee Dee Myers, Mike McCurry, Secretary-General Boutros Boutros-Ghali, Darren McDew, Dr. Connie Mariano, Prime Minister Yitzhak Rabin, President Carlos Salinas, President Franjo Tudjman, Neal Wolin, Mack McLarty, David Gergen, Don Baer, Secretary General Kofi Annan, Bob Boorstin, and Bob McNeely, among others.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore

records may be restricted in whole or in part in accordance with legal exemptions.
