## **Summary**

The photographs processed in this segment pertain to Linda Bloodworth-Thomason and events she attended during the Clinton administration. The photographs in this case are from events in Little Rock, Arkansas, Chicago, Illinois and at the White House from 1996 through 1998.

## **Scope and Content Note**

FOIA 2021-0263-F is a request for all photographs containing Linda Joyce BloodworthThomason. Linda Bloodworth-Thomason is the wife of Harry Thomason. Both Thomasons are television and film writers, producers, and directors, whom are friends of President William Jefferson Clinton and First Lady Hillary Rodham Clinton. The Thomasons worked in close capacity on the 1992 Presidential campaign and periodically worked on various productions during the Clinton administration. Events that are responsive to this case include speech preparation and watching election returns in Little Rock, Arkansas on November 5, 1996, departing for & arriving in Chicago on October, 27, 1997, at the First United Methodist Church on October 27, 1997, staff at the Ritz Carlton Hotel in Chicago, Illinois on October 28, 1997, in the Outer Oval Office of the White House on February 6, 1998, and preparing to deliver a statement to the nation following the President's Grand Jury testimony on August 17, 1998. Individuals photographed alongside the subject matter include President William Jefferson Clinton, First Lady Hillary Rodham Clinton, Chelsea Clinton, Vice President Al Gore, Elizabeth "Tipper" Gore, Dorothy Rodham, Roger Clinton, Tony Rodham, Nicole Boxer Rodham, Carolyn Huber, Harold Ickes, Maggie Williams, George Stephanopoulos, Nancy Hernreich, Mark Penn, Bruce Lindsey, Peter Knight, Leon Panetta, Warren Christopher, Rahm Emanuel, Glen Maes, Patti Solis, Laura Hardigan, Doug Sosnik, Marcia Hale, Capricia Marshall, Kelly Craighead, Lisa Caputo,

## **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
