## **Summary**

Also photographed includes President William Jefferson Clinton, First Lady Hillary Rodham Clinton, Nicole Kidman, George Clooney, Madeleine Albright, Kirk Hanlin, Barbara Kinney, Melanne Vermeer, Lissa Muscatine, Sean Connery, Harvey Weinstein, Joe DiMaggio, Gerald Levin, Walter Isaacson, Richard Parsons, Mikhail Gorbachev, Senator John Glenn, Walter Cronkite, Kevin Costner, Jodie Foster, Mary Tyler Moore, Lauren Bacall, Mira Sorvino, Reverend Billy Graham, Muhammad Ali, Ben Bradlee, Bill Richardson, Wendy Smith, and Liz Robinson, among many others. ## **System of Arrangement**

While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
