## **Summary**

This collection consists of Gene Sperling's textual files related to international financial institutions or IFI. This collection concerns the United States Congress and its financial support for the International Monetary Fund or IMF, the European Bank for Reconstruction and Developments or EBRD, the International Financial Institutions Advisory Commission or Meltzer Commission, IMF leadership, Multilateral Development Banks, New Arrangements to Borrow with the IMF, and the World Bank. The collection consists of articles, clippings, correspondence, remarks, reports, statements, and talking points.

## **Scope and Content Note**

The materials in FOIA 2020-0282-Fare a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. This collection contains Gene Sperling's textual files related to international financial institutions or IFI. Sperling served as Deputy Director of the National Economic Council or NEC from 1993 to 1996 and as NEC Director from 1996 to 2001. Organizations and programs in this collection related to international financial institutions include the United States Congress and its financial support for the International Monetary Fund or IMF, the European Bank for Reconstruction and Developments or EBRD, the International Financial Institutions Advisory Commission or Meltzer Commission, IMF leadership, Multilateral Development Banks, New Arrangements to Borrow with the IMF, and the World Bank. Geographical areas in the collection include Asia and the Asian financial crisis, Kosovo, Russia, and Ukraine. The collection contains articles, clippings, correspondence, remarks, reports, statements, and taking points. Many documents originated from Robert Wescott, Gene Sperling, and Lael Brainard in the National Economic Council (NEC)

and also Lawrence Summer and Timothy Geithner in the Treasury Department.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in these collection areas—Clinton Presidential Records: White House Staff and Office Files. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

## **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.
