Summary

This collection consists of records dating from 1993 to 2000 that include articles, briefing papers, clippings, correspondence, invitations, letters of recommendation and resumes, notes, publications, reports, scheduling materials, and speeches. Events include conferences, dinners, galas, speeches, and town halls associated with the Democratic Leadership Council or DLC. Topics include economic growth, gifts, healthcare reform, higher education, the Hyde Park Declaration, New Democrats, the North American Free Trade Agreement (NAFTA), the Third Way, and the first Presidential webcast.

Scope and Content Note

The materials in FOIA 2021-0328-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material. Records that are responsive to this FOIA request were found in these collection areas—Clinton Presidential Records: White House Office of Records Management (WHORM) Alpha Files, Clinton Presidential Records: WHORM Alpha Project, Clinton Presidential Records: WHORM Subject Files, Clinton Presidential Records: WHORM (OP), and Clinton Presidential Records: White House Staff and Office Files. The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Alpha file was compiled by the White House Office of Records Management from 1993 – 1996 and is a series of documents arranged by name of persons, organizations, or events. The WHORM Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. In addition, there are WHORM, WHORM Counsel, WHORM (CL), WHORM (OP), WHORM (Too Late); WHORM (Various Offices); and WHORM (Alpha Project) series. Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
